• Contact Tracing • Chair • Budget	• Dr. Getreuer stated everything appears to be working well. The challenge is the language barrier between English and Spanish. Positive COVID-19 patients have been good about communicating people they have been in contact with, as well as places they have visited. Glitches with IT have cropped up but get resolved quickly. The State HD has added an online translation service that will help. • Dr. Getreuer announced he is stepping down as chair. He has accepted the CEO position with Silver Source and cannot do both jobs. He is recommending Dr. Robertson as Chair. • Dr. Robertson, when asked, feels she has the time to do the job. P. Parry made a motion, seconded by Dr. Getreuer. Barbara Decker sent an email in support of Dr. Robertson. Negotiations with unions were successful. The HD did not lose any positions. In fact, the HD was approved for funds needed to hire an employee to begin preparation for applying for Accreditation. . The final budget has not yet been provided to the HC.	• P. Dr. Jennifer Calder: • Contact Tracing • Opening School • Grants	• Melissa Lopez, Assistant Director of Health, Director of Nursing and Dental was hired and began working in early August. She has been charged as the Administrator for contract tracing after there were many issues communication issues among volunteers in Stamford. . A structured onboarding package was created to streamline the expectation of Contact Tracers. We lost a number of volunteers due to school re-opening. • Nurses are inservicing for the opening of schools. Systems are in place in regards to how positive COVID-19 cases will be handled. Opening plans have been submitted and approved for all schools. • The SHD partnered with Family Centers and was awarded a grant from CT Health Foundation of \$214,000.00 for community health workers. One Supervisor and four community health workers who will be reaching out to individuals who are COVID positive, assisting with childcare, assisting seniors with groceries and medication, and educating individuals. Family Centers will be paying the workers and they will work at the HD.	• Pending MOU agreement w/ Southern CT State University, awaiting signature from the Mayor. Students in Public Health classes will then be able to help with contract tracing.

- Community Nursing - COVID - Influenza Immunization	- The State has funds from the CDC called “Epidemiology and Laboratory Capacity”. The SHD applied and was awarded a grant from the state from the funds received from the CDC, Awarded approximately \$700,000 over the course of a 3-year period. - Clinic – Two nurses have retired. - Monitoring daily COVID positive cases. - As reported in July, 8,100 thermometers were distributed to the public schools. The HD will be able to monitor temperatures if the app in the thermometer is activated. Dr. Calder told the HC that the City of New Haven is monitoring waste water for coronavirus titers. The mayor has reached out to New Haven to learn more. This is an old methodology from the time of polio. - Dr Calder said she is considering a drive through vaccination process. She is also reaching out to Police Department about flu vaccine. P Parry asked what the HD is charging this year. Dr. Calder said that Primary Medicare will be accepted but	Dept. of Health is in the process of interviewing for Supervisor and a Clinical Nurse.
