Appeal Hearing

The Appeal was opened by Ms. Parry at 10:20am and all Health Commissioners introduced themselves. Attorney Bernstein then made a statement that his clients have been involved in court proceedings in relation to the Apple Salon and past inspections and orders from the HD. Their position is that the owners of the property are not legally able to evict the owners for no cause and are waiting for a summary judgment from the court to initiate any action. Ms. Parry asked if there was a lease with the tenant. Atty. Bernstein indicated that there is no written lease. The tenant is paying the rental fee each month and the matter is being handled as a month to month rental until such time as the court issues an order.

Atty. Katz arrived shortly after Atty. Bernstein's statement and the cases represented by Atty.

Katz then proceeded. Inspector Ebrima Jobe presented the findings of the Apple Salon Inspection from February 15, 2013. The orders issued were reviewed and pictures were submitted for review. Atty. Katz asked Inspector Jobe about the citations and what he witnessed during the Inspection process. Then Sgt. Scutari from the SPD spoke about the police reports generated at the time of the inspection and submitted documents in support of the police reports. Atty. Katz asked Sgt. Scutari questions.

Atty. Katz then agreed that the observations documented in the orders from the DOH were factual as to the findings of the Inspection and that he was not challenging those. He presented a case that there was no evidence that the persons at these establishments, and named in the orders of the HD, were engaged in any massage because no such activity was witnessed.

Landlord Sergio Kailis of Palm Tree (Four Seasons) spoke on his position that he cannot act without legal direction. When asked, he said there is a lease for the space rented.

Sue Sgouris, daughter of Filimon and Argyri Sgouris, landlords of Swedish Health Spa, then made a statement that her parents are business people and that they have no idea of what happens in their building by tenants. Her parents do have counsel but she stated that it is costly. The tenants have violated their lease if they are

engaged in illegal activity. Her parents, the building's owners, continue to accept rent payments because they need the income. They are waiting until there is a court order to take action against the tenants so that they do not lose money on the space being rented.

At the conclusion of this evidence, Atty. Katz requested time to prepare a written brief to the HC in support of his clients' appeals. Due to personal vacation plans, he requested until July 11, 2013 to submit his case in writing. A transcript of the hearing will be available from the Law Department.

There being no further business, the appeal was closed at 12:20pm.

 A transcript of the appeal hearing may be obtained from the City of Stamford's Law Department. A vote by the Commissioners was unanimous in granting Atty. Katz until July 11, 2013 to submit his case in writing. The commissioners will review the written submission and render their decision for all cases in July.
