TO: UTILITY COMPANIES AND CONTRACTORS

RE: STREET OPENING/USE PERMITS – HOLIDAY SEASON – DOWNTOWN MORATORIUM

THE PURPOSE OF THIS LETTER IS TO NOTIFY ALL UTILITY COMPANIES AND CONTRACTORS OF THE DOWNTOWN MORATORIUM.

THE CITY OF STAMFORD MUST SCHEDULE ALL REQUESTED CONSTRUCTION ACTIVITIES DURING THE HOLIDAY SEASON IN ORDER TO PREVENT CONFLICTING SCHEDULES WITH THE VARIOUS CONTRACTORS DURING THE DOWNTOWN MORATORIUM.

THEREFORE, THE CITY OF STAMFORD REFRAINS FROM ISSUING ANY NON-EMERGENCY STREET OPENING PERMITS OR STREET USE PERMITS IN THE CENTRAL BUSINESS DISTRICT AND OTHER MAJOR TRAFFIC AREAS DURING THE FOLLOWING DATES:

NOVEMBER 15, 2021 – JANUARY 3, 2022

ANY WORK IN THESE AREAS MUST BE COMPLETED PRIOR TO NOVEMBER 14, 2021.

IN ORDER TO BE CONSIDERED FOR REVIEW AND APPROVAL OF ANY ANTICIPATED STREET USE ACTIVITY OR STREET OPENING EXCAVATIONS IN THE DOWNTOWN CENTRAL BUSINESS DISTRICT DURING THE ABOVE HOLIDAY PERIOD, THE APPLICANT MUST FILE A COMPLETED APPLICATION FORM & SUBMIT A LEGIBLE MAP/SKETCH INDICATING THE TYPE OF WORK AND LOCATION OF ACTIVITY BY NOVEMBER 14, 2021.

UPON FINAL REVIEW THE APPLICATION MAY BE APPROVED ON AN EMERGENCY BASIS OR DEFERRED UNTIL JANUARY 3, 2022.
