| <i>Item 4</i> | <p>Superintendent Earl Kim will be present to give Board members an update on the custodial overtime issue discussed at the July 12, 2018 meeting of the Board of Finance. At that time Mr. Kim provided Board members with a background on why custodial overtime, which had been running about \$1.2M per year, has increased steadily over the last few years to \$2.6M this past year. \$1.45M was budgeted. At that time, members requested that they be provided custodial overtime numbers for the last five (5) years and, included with these numbers, how many full-time and part-time custodians were employed during those years.
