REPORT OF AUDIT COMMITTEE MEETING OF THE BOARD OF FINANCE December 14, 2017

Presentation of draft report on Annual Internal Audit Plan/Risk Assessment Report 2017-18 Internal Auditor Teresa Viscariello: Chairman Freedman opened the meeting at 6:03 p.m. citing its purpose as noted and turned the presentation over to Internal Auditor Viscariello. Ms. Viscariello reported on six (6) recommendations, which were ranked in order of importance:

Annual Internal Audit Plan/Risk Assessment: 2017-2018

- 2. Operating Revenue and Expense Grants (Fund 24);
- City's Human Resources Transition of institutional knowledge and training delays to replace City employees in key roles processes (new);
- 4. City's Police and Fire Timekeeping and Attendance Processes and Approval;
- 5. Board of Education Human Resources Review of Extra Service Payroll Vouchers Approval Process; and
- 6. City's Credit Card Online Payment Processing Building Permits.
