Dear Mr. Stein & Members of the Zoning Board:

During its regularly scheduled meeting held on Tuesday, September 28, 2021, the Planning Board reviewed the above captioned application referred in accordance with the requirements of the Stamford Charter.

Applicant is proposing to open a Child Day Care Center located at the residential community of 1435 Bedford Street (Suite 1E) occupying a 4,201 sq. ft. space and consisting of six (6) classrooms along with a dedicated outside play area. There will be a total of ten (10) employees and will accommodate approximately fifty (50) children ranging in age from 4-months to 5-years-old. The applicant has acquired thirteen (13) designated garage level parking spaces in the 102 space underground garage. In addition, there is a total of 270 surface level parking spaces, which are available on a first come, first serve basis.

After some discussion, the Planning Board unanimously voted to recommend approval of ZB Application #221-27 and that this request is compatible with the neighborhood and consistent with Master Plan Category #5 (Residential - High Density Mulifamily).


