1. Review and Approval of previous meeting minutes.
2. Chairman's Report:
 - a. Code of ethics/ FOIA update; 10/23/21 Connecticut's Freedom of Information Act and the City's Code of Ethics have recently changed. The Connecticut Legislature enacted a series of statutory revisions to FOIA relating to the use of electronic meetings.
 - b. WPCA Permit Exceedance; 1/11/22, 29,000 gallons, treated/ non-disinfected effluent. Reason; Level sensor for UV channel 3 malfunctioned causing UV lamps to shut off for approximately 3 minutes on 2 occasions. Channel 3 was shut down and flow was diverted to channels 1 and 2. Receiving water: none given.
 - c. WPCA Permit Exceedance; 1/6/22, 1-5 gallons, raw sewage. Reason; Description of wastewater treatment plant Permit limit exceedance: A sanitary sewer overflow was reported today @7:40AM @ the intersection of Seaton Rd. and East Main St. The WPCA's 12" sewer line was blocked due to a build-up of rags and grease. Crews jetted the sewer line and cleaned the affected area. Approximately 1-5 gallons of wastewater bypassed the gravity sanitary sewer system. Receiving water: none given.

d. WPCA Permit Exceedance; 1/4/22, 6,175 gallons, treated/ non-disinfected effluent. Reason; UV low dose for ten minutes in Channel 2 caused by level control weir torque fault. The weir failed to maintain proper level in the channel. Up to 6,175 gallons were not disinfected. Receiving water: Stamford Harbor, East Branch.

SoundWaters will supply the gloves and buckets, they suggest attendees bring:Sturdy shoes or boots and warm clothes that can get dirty or wet.
