3. <u>REQUEST FOR RECOMMENDATION ON PROPOSED AMENDMENT TO SENIOR CITIZENS TAX ABATEMENT PROGRAM</u> (Video 00:06:06)

This is a request to recommend amending the Senior Citizens Tax Abatement Program to increase the qualifying income levels and abatement amounts to the Board of Representatives. As per local ordinance and state law, the program may be amended by vote of the Board of Representatives on recommendation of the Board of Finance.

Mayor Caroline Simmons gave a presentation on the Senior Citizens Tax Abatement Program and requested a recommendation be sent to the Board of Representatives to increase the qualifying income levels and abatement amounts of the Program.

Motion to increase all three qualifying income levels as proposed in the Mayor's Scenario #6 and increase the abatement benefit levels for the two lower income levels from \$2,000 to \$2,250, and from \$1,200 to \$1,325, respectively, and increase the program budget limit from \$2,000,000 to \$2,200,000 made by Richard Freedman, seconded by Mary Lou Rinaldi. Motion to amend the original motion to increase the abatement benefit for the highest income level from \$500 to \$625 made by Dennis Mahoney and seconded by Richard Freedman. Motion to amend passed unanimously, 6-0-0. Original motion, as amended, passed 5-1-0, J.R. McMullen opposed.

Motion to increase program budget limit from \$2,200,000 to \$2,500,000 by J.R. McMullen, seconded by Dennis Mahoney. Vote failed 1-5-0, J.R. McMullen voting in favor.
