C. Harkey opened the meeting by thanking all who attended. The purpose of the meeting was to keep the continuity flowing between SVPP and the P&SEC for 2022 events while the official P&SEC meetings are being set.

D. Kaplan shared there was no additional information to share about the meetings or the budget as of yet. D. Kaplan, C. Munger, and P. The group agreed last year's parade and ceremony schedule went well and no changes were proposed for 2022. Last year National Pearl Harbor Remembrance Day was 80th year anniversary and S. Fischer will confirm if the veterans would like to host a ceremony this year for the 81st anniversary. The group agreed the parades were a great success in 2021 and would like to continue with them in 2022. D. Kaplan will do some preliminary work to get parade participants engaged and ask them to reserve the dates for both the Memorial Day and Veterans Day. P. Parry spoke about hosting an independent event for the Gold Star Monument and C. Harkey spoke about the event for the inclusion of Mary Nurney on the monolith wall. Dates for both events depend on the completion of the engraving in the park.

The meeting closed at 12:50 pm. D. Kaplan will keep the group informed regarding the date for the first P&SEC meeting in 2022.
