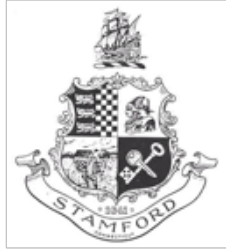

 - a. 205 Magee Ave Facility Update; 2-7-22 the CoS ZB had a brief update regarding the status of work at the future facility. Additional remediation of brown fields has needed to be done causing significant delays. The developer is working with DEEP on the process.
 - b. West Beach Ramp/ Cove Dredging; The current placeholder schedule for construction of the West Beach boat ramp which accords with the timing of the State permit: Project goes out to bid Dec 2022, bids due back Feb 2023, mobilize June, construction substantially complete Oct, dredging Oct+. Land Use is looking into doing a partial dredge in the Cove Island marina fall 2022, which could result in reasonable access to the Cove Island boat ramp to make up for the closure of the West Beach boat ramp for construction. Land Use is working with consultants to update the survey at the Cove in pursuit of finalizing the permit.
