Minutes – Regular Fire Commission held February 8, 2022 Call to order: 5:09 pm

<u>Roll Call, Pledge of Allegiance, Moment of Silence</u>: Present: Commissioner Alswanger, Commissioner Baker, Commissioner Hill, Commissioner Hubbard, Commissioner Munger, PSH&W Director Jankowski, Fire Chief Trevor Roach, Assistant Chier Morris, Assistant Chief Robles.

<u>Chief's Report</u>: Fire Chief Roach gave a briefing on Stamford Fire department stating 1063 calls, 33 of which were fire, 566 medical. Sick leave was discussed. Commissioner Alswanger inquired into the new project Waterton Senior residence as to its status. Discussion took place. Chief Roach stated that the hydrant project is ongoing and in tandem with Aquarions main project.

Personnel Issues:

Chief Roach breifed the new members of the Commission on the ongoing litigation and personnel interviews. It was asked that the Legal department be invited to the next meeting to give a briefing and answer any questions the Commission may have. It was agreed by the Commission that it would be beneficial to have the firm Morris & McDaniel to the Fire Commission meeting to discuss the exam process and items associated with that.
