| An automated side load refuse truck is critical and necessary to the operations of the Solid Waste Department. The truck this requisition is for is in stock and can be delivered one week after receipt of the purchase Order. In addition, due to supply chain shortages, steel surcharges and manpower issue at the manufacture level, a new truck would take over a year to be delivered. In that year plus waiting for the new truck to arrive the cost to maintain the existing fleet will increase, the Vehicle Maintenance Department will incur overtime to keep the refuse fleet on the road as well as the Solid Waste Department would need overtime on a daily basis to be able to pick up garbage in a timely basis. Furthermore, the cost of a truck procured through a bid would be 10%- 15% or more higher than this truck. | | | | | | | |
