Follow a brief discussion, a motion was made by Mr. Morris for approval of the memo to the Board of Representatives prepared by Mr. Blessing and also of the referral of the petition to the Board of Representatives, seconded by Ms. McManus and carried on a vote of 5 to 0 (Stein, Morris, McManus, Quick & Rosenfeld.
