Clinic offering blood pressure screening, and other chronic disease prevention tactics. • COVID – 19: Test kits have been distributed by State Department of Health to the City and all schools. • Vaccination program remains active in the community at multiple locations. Westover School, and the state supported site at St. Mary's are the most popular by visit numbers. Hours will be reduced at both sites in accordance with data received from the State of around 100 cases per week, and a 3 – 4% positivity rate which has been stable. • Contract Tracing: Moving away from individual case investigation. Focusing on nursing homes, day cares, schools and congregate settings. • Emergency Preparedness: Distributed thousands of masks and test kits. Requests still coming in from City agencies and non-profits. • Community Needs Assessment with Stamford Hospital is ongoing. • Presenting Health Department budget to Finance Committee. • Intern(s): A Nursing intern from University of Bridgeport will be working with the Health Department. There could be serious liability issues for the City if an accident like this occurs on City property. - Commissioner Lorraine Olson asked for clarification on the process on how the selection process for Health Director works. - Nursing: Community Nursing. Still down a nurse. A school nurse has expressed interest in this position. - School nursing – A school nurse will be starting this month on March 21, 2022. One more vacancy remains before school nursing is at capacity.	- Ms. Bishop-Pullan will contact the agencies involved in running the City owned rinks for information - Mr. Jankowski replied that eight candidates are being interviewed by a panel that consists of Mr. Jankowski, former Director of Environmental Health and Inspections, Ron Miller, and Medical Director, Dr. Henry Yoon. Once the candidate pool is reduced to two candidates, Health Commissioner Lorraine Olson along with another Commissioner can interview them as well and make a recommendation to Mayor Simmons.

Believes there should be at least four. • Staffing: Two new inspectors have been hired and are shadowing with other inspectors. One of the new inspectors is certified in septic. Another inspector will be coming on board on March 28th as an Inspector II, and is a Registered Sanitarian (RS). She is already certified in Lead, Food, Septic, and Pools. • No formal appeal process in place. Raquelle proposed having an online form that breaks down the appeal process. • Raquelle addressed updating outdated information.	• Ms. Bishop-Pullan stated that the position is in the Budget being submitted. • Ms. Parry was dubious that this was necessary. Feels that this might place an undue burden on computer illiterate citizens. • Dr. Getreuer will work with Ms. Early to develop the form.
