# **RECREATION** (NEW IN BOLD):

- All spring/summer preparation in process (recruiting, interviewing and hiring administration) for approximately 300 seasonal staff.
- Summer day camps 100% full. Large waiting lists. Note for future, as City continues to grow. *182* on wait list.
- Beginning to work on payment plans and sponsorship dollars for needy camp families.
- Field permits almost completed for spring/summer play. Activity *began April 9, 2022 for all youth sports*.
- Use requests for parks, fields, tournaments and events heavy. This function needs a review. Heavy clerical functions; should not be done by a recreation professional. Time better spent on programming.
- External sanctioned leagues permits in process and some issued.
- Parks & Recreation Commission will entertain two new youth tennis organizations for court sanctioning. Both non-profits, all Stamford kids and affiliations with national tennis programs, which is a requirement for sanctioning per our policy. Grassroots Tennis and Six Love Tennis.
- COVID waivers for external organizations only continuing per my request to Legal. No longer for each individual player.
- Spring program registration ongoing and filling up most programs.
- Adult internal leagues filling up. 180+ softball teams; anticipate 90 beach volleyball (in May), 20 Kickball.
- Working with attorney, Dana Lee, regarding the placement in summer camp of a severe special needs
  child who is outsourced for a higher level of care by the Board of Education during the school year.
  We are concerned our camp environment and our ability to accommodate this child is beyond our
  scope.
- Lifeguard training class finished. Class certified 5 new lifeguards and 3 re-certifications. Hope to hire all 8.
- Spring/Summer purchasing in process for camps, leagues and aquatics. *Office of Policy & Management* (OPM) requested Q3 revenue and expenses reported.
- Potential donated disc golf course proposed for Cummings Park for May Parks & Recreation Commission agenda? More details to follow, but first glance I have a few questions and concerns.

# **TERRY CONNER RINK:** (NEW IN BOLD)

- Stop the Bleed Kit: Working with Legal on what has been proposed to be provided by Greenwich Hospital, including training. I have some concerns. Copied Matthew Quiñones, Director of Operations, on my email to Legal with them.
- New interior roof ladder with steps and handles recycled from the old Police Station. Thanks to Engineering.
- Charity hockey game between Stamford Police Department and Stamford Fire Department on April 30, 2022 at 2:30 p.m. Rink will not charge and game staff will collect a \$10 donation, not rink staff. Proceeds to Stamford Police Department for officer and longtime hockey coach, Doug Robinson, who is battling cancer.
- Preparing for summer camp and selling spring ice.
- COVID waivers will continue per Legal for external organizations; no longer for each player/user.
- Olympia sale in works. Recreation software creating an invoice for Bill Klous who will then facilitate from there. \$32K to the General Fund and will appropriate to rink fund for purchase of a used back up machine. *Invoice sent by Recreation to resurface. Waiting on check and then a pickup date.*
- Completed specifications for a food service with a food truck option. Sent to on Erik Larson, Purchasing Manager, for placement on bid calendar.
- Policy revision in process. *Now about ¾ done*.
- The following are projects planned before the fiscal year ends. Will most likely hold off on Item #2 unless something changes with shipping costs.
  - 1. Becker Arena: Screws and polyethylene boards for the outside perimeter of the rink. (Many are looking shabby and need replacement as they are cracked or broken in place.) Have an estimate for 10 pieces with shipping for \$2,160.00 *Requisition in*.
  - 2. A potential second order from Becker for continuation of our rink glass project. (Raising all to 5 ft. for additional safety.) Shipping charges are ridiculous so may not do this one as a result.
  - 3. Having a company coming (Resurfix) to do a spring service on our Zamboni at a cost of \$4,300.00. Is pricely but some of the diagnostics they do are out of our abilities as we lack the proper diagnostic tools. A lot is checked and changed though, so I think we should have this done. *Working on a date.*
  - 4. Will schedule Controlled Dehumidification in the late spring to come do a service check/change for our unit. Will get a quote soon for this once I scrub our Building Maintenance Budget/Small Capital Equipment to make sure we have the funds. *Working on a date*.
- White plastic panel side boards being replaced on lobby side of rink.
- All other end-of-year spending on going now. *OPM requested Q3 revenues and expenses reported.*
- Replacing rink's two front doors with new panic bar assemblies.
- Rink awarded \$1 million in State grant for the roof replacement. Waiting on further information and a timeline. Will do at time of year when revenue impact is less.

- Waiting on final budget numbers for FY 2022/2023
- Recreation offices will be moved to the 6th Floor to keep Tax and Permitting together on 1st Floor.

- New time payroll system in June. Training started.
- New financial Citywide software transition work in process, especially interface with recreation and rink management software.

There being no further business to come before the Commission, Mr. Newman adjourned the meeting at 9:32 p.m.
