# RESOLUTION WITH RESPECT TO THE ISSUANCE AND SALE OF \$40,000,000 GENERAL OBLIGATION BONDS OF THE CITY OF STAMFORD, CONNECTICUT, ISSUE OF 2022

#### BE IT RESOLVED BY THE BOARD OF FINANCE OF THE CITY OF STAMFORD:

Section 1. Under and pursuant to the provisions of the Charter of the City of Stamford, Connecticut (the "City") and all other general or special laws thereto enabling, and under and pursuant to the resolutions of the Board of Representatives providing for the authorization of bonds to pay for certain capital appropriations, there be and hereby is approved, in the name and upon the full faith and credit of the City the issuance of \$40,000,000 City of Stamford, Connecticut General Obligation Bonds, Issue of 2022 (the "Bonds"), to fund the capital appropriations set forth in the attached Schedule A. The Mayor and the Director of Administration may transfer bond proceeds in an amount not exceeding twenty percent (20%) of the aggregate principal amount of the Bonds from the capital appropriations set forth in Schedule A to any other capital appropriations heretofore or hereafter approved by the Board of Finance and the Board of Representatives for financing with bonds, subject to action by the Board of Finance as described herein. The Mayor and the Director of Administration shall notify the Board of Finance of the amount, the capital appropriation affected thereby, and the reason for any such transfer from Schedule A. If within forty-five (45) days of receipt of such notification the Board of Finance does not reject such transfer, such transfer shall be deemed approved.

The Bonds shall be issued and sold by the Mayor and the Director of Administration in a competitive offering and shall be awarded by the Mayor and the Director of Administration to the bidder or bidders offering to purchase the Bonds at the lowest true interest cost to the City, in no case for a sum less than par and accrued interest, if any, to the date of delivery. The Bonds shall mature in such amounts and at such time or times as shall be determined by the Mayor and the Director of Administration in compliance with the Connecticut General Statutes. The Bonds shall be executed in the name and on behalf of the City by the manual or facsimile signatures of the Mayor and the Controller, bear the City seal or a facsimile thereof, and be approved as to their legality by Pullman & Comley, LLC, Bond Counsel. The Bonds shall be general obligations of the City and each of the Bonds shall recite that every requirement of law relating to its issue has been duly complied with, that such bond is within every debt and other limit prescribed by law, and that the full faith and credit of the City are pledged to the payment of the principal thereof and the interest thereon. The denominations, form, details, and other particulars thereof, including designation of the certifying, registrar, transfer and paying agent, the terms of any rights of redemption and redemption prices shall be determined by the Mayor and the Director of Administration.

- Section 2. The Mayor and Director of Administration are authorized to prepare and distribute a Preliminary Official Statement and a final Official Statement of the City for use in connection with the offering and sale of the Bonds and are further authorized to execute and deliver a continuing disclosure agreement in connection with the issuance and sale of the Bonds on behalf of the City in such form as they shall deem necessary and appropriate.
- Section 3. The Mayor and the Director of Administration are authorized to execute and deliver a tax regulatory agreement for the Bonds on behalf of the City in such form as they shall deem necessary and appropriate, and to rebate to the federal government such amounts as may be required pursuant to the tax regulatory agreement for the purpose of complying with the requirements of the Internal Revenue Code of 1986, as amended.
- Section 4. The Mayor and the Director of Administration are authorized to execute and deliver any and all agreements and documents necessary to effect the issuance and sale of the Bonds in accordance with the terms of this resolution, including the investment of the proceeds of the Bonds.
