REPORT MEETING Tuesday, April 27, 2022 7:00 p.m.

- 1. Co- Chair Lombardo called the meeting to order at 7:09 p.m. due to technical difficulties.
- 2. Co- Chair Lombardo asked the clerk to take attendance through those present on ZOOM.
- 3. Co- Chair Lombardo confirmed we had a quorum to proceed.
- 4. Commissioner Larobina led the Pledge of Allegiance.
- Co- Chair Thomas Lombardo asked that we take the agenda out of order, the guest Speakers were moved to item 4. He introduced the two guest speakers: Attorney Steve Mednick, Deputy Director Ron Thomas of Connecticut Conference of Municipalities.

- 12. Co Chair Kolenberg confirmed the budget allocation \$100,000 for legal counsel for 2021/2022 and then for fiscal year 2022/23, totaling approximately \$200,000 for the duration of the Commission's work
