Stamford Bocce League 2022 Scalzi Park Bocce Courts License and Use Agreement

Term: The Term of this Agreement shall commence when last signed below and terminate on October 31, 2022.

License and Use: The City grants the League a nonexclusive revocable right to use that portion of the City's Scalzi Park commonly known as the bocce courts, as depicted on the map attached hereto as Schedule A, for the purpose of operating a bocce league and no other use.

Hours of Use: The League may use the bocce courts only during the hours of 5:30 a.m. through midnight each day.

Fees Charged: The League shall pay a one-time light use fee of Three Hundred Dollars (\$300.00) payable upon receipt of City permit.

City's Responsibilities: The City shall be responsible for basic maintenance to include mowing, trimming, garbage barrels and garbage removal.


Bocce League's Responsibilities: The League shall be responsible for all court replacement and repair to include clay surface, wood border fence and bocce supplies, not to exceed Three Thousand Dollars (\$3,000.00), and shall provide the City a report of work completed on or before October 1, 2022.

Indemnification: The League shall indemnify, hold harmless and, at the City's option, defend the City, its officers, agents and employees, from third party claims for loss, cost, damage, liability, and/or injury to or death of a person, including the agents and employees of the League, or loss of or damage to property, resulting directly or indirectly from the League's negligent acts or omissions related to the bocce league activities that are the subject of this Agreement. The foregoing indemnity shall include reasonable attorneys' fees and costs of suit, if applicable, shall not be limited by reason of any insurance coverage required pursuant to this Agreement, and shall survive the termination of this Agreement.

Insurance: The League shall provide a Certificate of Insurance evidencing coverages acceptable to the City's Risk Manager.

No Assignment. The League may not assign or transfer any of its rights granted by this Agreement under any circumstances.


