2. Technical Response/Corporate Experience and Capacity

Background on Sustainable Strategies DC

Sustainable Strategies DC is a government affairs, strategic consulting, and grant writing firm based in Washington, DC, that helps clients secure resources for community revitalization. We represent local governments across the nation. The types of services provided include project funding guidance, grant writing, congressional and agency advocacy, consulting on a wide range community revitalization issues, support for the formation of public-private partnerships, management of national coalitions of localities promoting municipal interests at the federal level, and environmental legal counsel. We have helped communities across America succeed on innovative local projects and secured hundreds of millions of dollars for those initiatives.

The Sustainable Strategies DC team has extensive experience meeting the funding needs of local governments. Over the years, we have helped communities secure state and federal grants, foundation dollars, congressional authorizations, earmarked appropriations, technical assistance, and other resources for their local priorities. Recent Successes

Over close to 30 years, the Sustainable Strategies DC team has secured more than \$5 billion for its local government clients. This includes more than \$585 million in grants and other resources secured for cities, towns, counties, and states across America since just 2012. The firm's work supports diverse local communities across America of all sizes, with populations ranging from 5,000 to 1.5 million.

Recent examples of success with communities include the following, each of which required a combination of strategic consulting, the building of partnerships with stakeholders and allied organizations, grant writing, and federal and state advocacy, among other activities:

- In 2021-2022, Sustainable Strategies DC helped the City of Rochester, MN, to be designated a Mayor's Global Challenge winner by Bloomberg Philanthropies, with \$1 million in prize winnings through an international competition. Rochester's project focuses on the economic mobility of Black, Indigenous, and People of Color (BIPOC) women

- through careers in all-phases of the built environment and construction. This work has been conducted by Ashley Badesch with the assistance of Andrew Seth.
- Sustainable Strategies DC worked with localities across the Pittsburgh region to secure \$10+ million for advanced manufacturing and business innovation from the EDA, Appalachian Regional Commission, and Department of Defense. This work was conducted by Matt Ward with the assistance of Ashley Badesch.
- Sustainable Strategies DC prepared a winning grant application for \$508,000 in Outdoor Recreation Legacy Partnership funding from the National Park Service to support the development of basketball courts and a community center in a low-income Dubuque, IA, neighborhood. This work was conducted by Andrew Seth.
- Sustainable Strategies DC assisted the City of Glenwood Springs, CO, in receiving a \$200,000 EPA Brownfields Area-Wide Planning grant to conduct market analyses and infrastructure studies in a priority redevelopment area, plus \$10.8 million more in grants in our first three years of representing that community. As referenced above, Sustainable Strategies DC's services to these clients included:

- Building stakeholder support from community organizations, the private sector, regional entities, and state agencies;
- Fostering collaboration between the client and key federal agency funding managers;
- Grant review of proposals written by experienced City staff;
- Grant writing for particular applications; and
- Advocacy to federal agency leaders and Congress in support of grant proposals.

Accomplishments for Stamford

The Sustainable Strategies DC team has been pleased to serve as the City of Stamford's federal lobbyist and strategic consultant between 1999 and 2018, and beginning again in mid-2021. We are very excited about the positive results of our relationship with Stamford. Since 1999, we have developed a solid understanding of Stamford's community revitalization priorities. Through our work with the City, we understand the critical problem of clogged local roads, the need for

additional transit options, the difficult problem of insufficient/affordable housing, the redevelopment opportunities on the south waterfront, the importance of the Mill River restoration, the need for public safety funding in a community that is growing and changing, and the necessity to leverage resources in tight budget times. As such, we believe that our track record of success, our strong team of lobbyists and grant writers, and our understanding of Stamford's priorities and goals make us ideally suited to continue our federal lobbying efforts for the City.

Sustainable Strategies DC has also worked with Stamford to demonstrate the City's national leadership on smart growth, brownfields redevelopment, waterfront revitalization, transit-oriented development, and emerging clean energy issues. Our team has helped Stamford participate as a founding leader of several key national initiatives, including the EPA Brownfields Showcase Community Initiative, the Climate Communities coalition, the American Waterfront Revitalization Coalition, and the First & Main Coalition.

Sustainable Strategies DC has successfully worked to secure direct federal congressional and agency grants for Stamford, including support for the Stamford Urban Transitway, the Atlantic Street rail underpass improvements, the Mill River revitalization, Fairgate Farms, law enforcement communications, various streetscape improvement projects, the West Main Street walking bridge project, affordable housing projects, brownfields and public health projects, public safety resources, West End revitalization, and other community priorities. The Sustainable Strategies DC team has also worked to successfully authorize more than \$101 million in transportation and waterfront revitalization projects through transportation reauthorization legislation and the Water Resources Development Act.

Historically, our work with Stamford has included:

Public Safety – Sustainable Strategies DC helped Stamford secure \$1 million from FEMA to hire additional firefighters in the community, as well as launch a body-worn camera initiative with a \$338,346 DOJ grant. Sustainable Strategies DC helped Stamford obtain more than \$2.2 million in "Law Enforcement Technology" grant funding for converting Stamford's portable radios to digital technology, expanding capacity at the Stamford 911 center, and creating a secondary Public Safety Answering Point to have full multi-redundant capability, along with GIS technology improvements.

Public Health – Sustainable Strategies DC has been actively engaged in helping Stamford create a culture of health. Our firm helped the community secure several grants from the Robert Wood Johnson Foundation for its wellness efforts, including \$60,000 in Invest Health funds to reduce gun violence, \$20,000 in Roadmaps Collaborative Learning funds to work with Bridgeport and Norwalk on health metrics, and a \$10,000 Roadmaps to Health Action Award to plan for healthy behavior in the West Side.

Transportation – Sustainable Strategies DC secured federal funding for the planning and design of Atlantic Street rail underpass improvements. We helped Stamford reprogram \$1.4 million in federal earmarked transportation funds for key local road projects. The firm positioned Stamford to be selected by the Federal Transit Administration (FTA) and Smart Growth America for transit-oriented development technical assistance in the pilot year of that federal program. The Sustainable Strategies DC team helped Stamford obtain more than \$75 million in federal funding for Phases 1 and 2 of Stamford Urban Transitway construction. Our team secured \$3.5 million in federal transportation funding for transportation projects on the south waterfront, \$250,000 in federal highway funding for streetscape improvements in the Waterside neighborhood, and \$850,000 to reconstruct the West Main Street pedestrian bridge. Sustainable Strategies DC also helped Stamford to become the first locality in America to undertake the "Safer People, Safer Streets Challenge" issued by then U.S. Transportation Secretary Anthony Foxx.

Mill River Restoration – Sustainable Strategies DC has helped Stamford obtain significant funding for multiple aspects of the Mill River Restoration, including \$1.6 million in NOAA Coastal and Estuarine Preservation funding for land acquisition at the Stampark parcel and other key parcels; \$1.8 million for stormwater infrastructure projects on the Mill River; and \$215,000 in HUD Economic Development Initiative (EDI) funds for land acquisition. Our team has also worked closely with Stamford, the New England District of the U.S. Army Corps of Engineers, and the Corps' headquarters to launch an ecosystem restoration project of Mill River, supported by more than \$5 million in funding from Congress. We have prepared for and facilitated meetings with key federal officials, including the Commander of the Corps of Engineers, the Commander of the Corps Civil Works Division, the civilian director of the Civil Works Division, the Corps' chief of legislation, and the Corps' Chief of Environmental Programs.

Sound End Revitalization – Sustainable Strategies DC has supported Stamford's development of its South End. The firm's efforts to secure brownfields funding helped launch the initial revitalization of the South End. Transportation improvement at the intermodal center has supported the area's redevelopment. Sustainable Strategies DC also secured \$800,000 in EDA Disaster Relief funds to improve flood control gates and protect the South End from the impacts of climate change and natural disasters.

West Side Revitalization – Sustainable Strategies DC has been integrally involved in supporting the revitalization of Stamford's West Side. Our firm has helped strengthen Fairgate Farm with a \$147,840 USDA grant to support the sale of organic produce and a \$25,000 EPA grant for composting. Stamford received EPA smart growth technical assistance to prevent gentrification in the West Side. Sustainable Strategies DC provided substantial assistance to Charter Oak Communities in the City's successful effort to obtain \$19.8 million in HUD HOPE VI funding for the Fairfield Court housing and social services project. Sustainable Strategies DC also prepared

successful applications that enabled Stamford to launch \$1.1 million in planning efforts for the VITA health and wellness district on the City's West Side.

Public Housing – Sustainable Strategies DC helped develop the strategy that led to \$6.4 million in HUD Disaster Relief funds for the replacement of the Hurricane Sandy-damaged Czescik Homes. The firm also prepared a public housing funding strategy for Inspirica at the City's request. Sustainable Strategies DC also helped Stamford obtain \$850,000 in grant funding from the HUD "Healthy Homes" program to support the City's asthma reduction initiative in low- and moderate-income housing in Stamford.

Brownfields – Sustainable Strategies DC's lobbyists have been closely involved with Stamford in your efforts to revitalize brownfields properties and protect public health. We supported Stamford's effort to obtain \$500,000 in EPA funding to capitalize a brownfields revolving loan fund. We have helped Stamford to enhance their role in the national brownfields movement through testimony before Congress, speeches at national conferences, and involvement in the Brownfields Showcase Community Initiative.

Historic Preservation – Sustainable Strategies DC worked with Stamford and the Keeper of the National Register of Historic Places to craft and implement a strategy for the preservation and relocation of the Hoyt-Barnum House.

National Visibility for Stamford – We have helped the City enhance its leadership position in the community revitalization field by securing opportunities for Stamford to receive national visibility. Specifically, we helped secure opportunities to deliver keynote speeches at national conferences, present testimony to Congress, and host federal agency and congressional delegation visits to showcase the City's economic development and sustainability projects.

Over the years, these efforts have been conducted by Andrew Seth, Ashley Badesch, and Matt Ward.

Since recommencing our funding and advocacy relationship with Stamford in mid-2021, we have worked to track various federal activities and legislation of importance to the community, including:

- Presidential Transition Sustainable Strategies DC put together a group of local government leaders to advise the Biden Administration in early 2021. These mayors (including Mayor David Martin) signed on to a policy platform that urged major federal investment in community revitalization.
- American Rescue Plan Act Sustainable Strategies DC worked with Stamford and localities across America to encourage passage of the American Rescue Plan Act, which

- provided resources to help local governments recover from the economic impacts of the impact. We also coordinated closely with the Stamford team on the appropriate use of Coronavirus State and Local Fiscal Recovery Funds.
- Bipartisan Infrastructure Legislation Sustainable Strategies DC actively supported passage of the Infrastructure Investment and Jobs Act, a once-in-a-generation investment in our nation's infrastructure and competitiveness. We have been counseling Stamford since late 2021 on how to be best prepared for the rollout of this funding in 2022.
- Build Back Better Act Sustainable Strategies DC has lobbied for a strong local government focus in the proposed Build Back Better Act, which includes resources for climate change, resiliency, housing, and other social programs.

Sustainable Strategies DC has also pursued multiple funding opportunities for Stamford over the last 10 months, working with the City to develop project ideas, prepare grant applications, and lobby for congressional and agency support. Already, the City has been awarded \$133,151 from the DOJ for body-worn cameras with a grant application prepared by Sustainable Strategies DC. Many other requests for federal funding will be decided in the next few months. Pending applications with a high likelihood of success include:

- Earmark Sustainable Strategies DC worked with Congressman Jim Himes to include a \$2 million earmark in appropriations legislation that will help Stamford ensure safe and easy pedestrian access to local public schools and transit facilities. Bill passage is anticipated in mid-February.
- Earmark Sustainable Strategies DC prepared a successful \$513,000 earmark request to Senators Blumenthal and Murphy in support of pre-apprenticeship training.
- Building Resilience in Communities Sustainable Strategies DC wrote a grant application requesting \$2.7 million to upgrade deteriorating flood protection infrastructure. The Stamford Water Pollution Control Authority operates and maintains three stormwater pumping stations (Cummings, Dyke Lane, and Wampanaw) as part of the Stamford Hurricane Protection Barrier. Although well maintained, much of the equipment is original and in need of replacement. Sustainable Strategies also prepared Mayor Simmons to lobby Commissioner James Rovella to advance Stamford's application to FEMA.
- Outdoor Recreation Legacy Partnership Program Sustainable Strategies DC prepared a
 grant application to the National Park Service (NPS) requesting \$1.8 million for
 recreational improvements at Boccuzzi Park. Mayor Simmons participated on an effective
 call with Joel Lynch, NPS Chief of State and Local Assistance Programs, in support of this
 request.
- Community Food Projects Sustainable Strategies DC worked with Charter Oak Communities to draft a grant application to USDA requesting \$205,300 to develop a commercial-grade demonstration kitchen at Fairgate Farm that will help meet the food needs of low-income and minority residents in Stamford's West Side.

• Our Town Grant – Sustainable Strategies DC worked with Stamford and the Cultural Alliance of Fairfield County to submit a \$100,000 grant application to the NEA supporting the design and installation of a sculpture in the Cove neighborhood, a youth-supported mural on the West Side, and a creative LED display in downtown Stamford.

A number of grant applications are also currently under development, including:

- Good Jobs Challenge Sustainable Strategies DC is working with the Mayor's Youth Employment Program to get Stamford included in the State of Connecticut's EDA Good Jobs Challenge application. If successful, Connecticut has pledged significant resources to the Stamford Partnership to conduct regional workforce development activities. The City would receive funding to help young adults (18-24) develop the skills necessary to complete the training. The EDA Good Jobs Challenge application is due February 10.
- Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Sustainable
 Strategies DC has begun working with Stamford develop a transportation infrastructure
 project (possibly the Lower Atlantic and State Street) that will be competitive for DOT
 RAISE funding. Applications are due April 14.
- Grants for Arts Projects Sustainable Strategies DC is working with Stamford to develop an NEA Grants for Arts Project application (due February 22) to support the creation of a mural at the transit center garage. With funding, the City will commission the artist DAAS to develop public art that reflects the values of the community.
- Brownfields Sustainable Strategies DC is working with Stamford to identify resources for the assessment and cleanup of contamination at Boccuzzi Park. EPA Region 1 may be able to conduct Phase I and II assessments at the site. EPA will have cleanup funding (up to \$5 million) available this summer.
- Cybersecurity The Bipartisan Infrastructure Bill includes significant funding for local cybersecurity efforts. Sustainable Strategies DC helped Stamford develop a relationship with the state officials who will decide how to spend those dollars. We also encouraged Stamford to volunteer to serve on the state advisory committee that will decide cybersecurity priorities. Cybersecurity funding will be available in mid-2022.
- Farm Viability Grant Sustainable Strategies DC is seeking Farm Viability funding from the Connecticut Department of Agriculture to develop educational materials, upgrade equipment, and implement a farm experience program at Fairgate Farm. Applications are due February 14.

Proposed Scope of Services

The team's specialized approach would enable Stamford to continue identifying short- and long-term opportunities for funding, public-private partnerships, best practices, and other resources to implement the City's community priorities. Our work would involve:

- Strategy Session in Stamford: Face-to-face interaction on major initiatives is always beneficial, and the Sustainable Strategies DC team would propose to kick-off its effort with an in-person (or Zoom as appropriate) strategy session in Stamford in March 2022, where we could re-connect with City staff and other key participants to discuss community priorities, explore grant opportunities, and develop a funding gameplan. The team would prepare an agenda and background materials for these meetings, in coordination with Stamford.
- Stamford Resource Roadmap: The output of the strategy session in Stamford will be the creation of a robust Resource Roadmap that will help guide our work with the City in 2022 and beyond. This will consist of a matrix of state, federal, philanthropic, and private sector opportunities for funding and other resources. That matrix will include opportunities for which we believe Stamford is both eligible and competitive, projections of likely funding ranges, discussion of matching requirements, discussion of key strategic approaches to make you successful for those resources, identification of key officials for each resource, identification of deadlines and important preliminary steps, considerations of new and changed opportunities in light of national policy and resource decisions, and recommendations on key next actions.
- Implementation of the Stamford Resource Roadmap Sustainable Strategies DC provides a full suite of services in tracking funding opportunities, grant writing, public-private partnership facilitation and building, coordination with agencies and legislative officials working in partnership with the City's lobbying team, organization of stakeholder support, development of materials, grants management, and other consulting. Activities that will advance the Stamford's community priorities include:
 - a. The team will engage with Stamford staff through **weekly conference calls** to provide updates on grant opportunities;
 - Frequent communication with Stamford staff between conference calls to advance grant proposals;
 - c. The team will **organize meetings** (and/or Zooms) in Washington, DC, for Mayor Simmons and Stamford staff to meet with federal leaders who can help support the City's community priorities;

- d. The team will seek opportunities to **bring state, federal, and foundation leaders to Stamford** to tour your projects and strengthen relationships;
- e. The team will determine with Stamford staff which funding opportunities make sense for the City and perform the **ongoing grant services**:
 - Strategic advice to shape projects to be more competitive for funding;
 - **Coordination** with the City's grants team, with whom we have worked more than a decade:
 - **Grant review** of proposals that experienced Stamford staff prepare;
 - **Grant writing** of particular funding applications;
 - Organization of broad stakeholder support across the community, region, and state; and
 - **Grant submission** through grants.gov or by mail.
- f. The team will conduct **advocacy** to federal agency leaders and Stamford's congressional delegation.
- **g.** The team will perform other support for Stamford, including helping the **City overcome grants management challenges** with the federal agencies.

5. Fee Proposal

Sustainable Strategies DC proposes a fee arrangement of \$120,600 annually, which includes a monthly retainer of \$10,000, and a \$50 fee communications fee every month to cover expenses such as long-distance charges, conference calls, faxes, copying, printing, and other office expenses. Stamford will be billed separately for reimbursable expenses such as out-of-town travel (pre-approved by client), in-town travel (taxi cabs), overnight delivery, and courier services.

COMMISSION ON HUMAN RIGHTS AND OPPORTUNITIES CONTRACT COMPLIANCE REGULATIONS NOTIFICATION TO BIDDERS

The contract to be awarded is subject to contract compliance requirements mandated by Sections 4a-60 and 4a-60a of the Connecticut General Statutes; and, when the awarding agency is the State, Sections 46a-71(d) and 46a-81i(d) of the Connecticut General Statutes. An individual with a disability is also a minority business enterprise as provided by Section 4a-60g of the Connecticut General Statutes. The above definitions apply to the contract compliance requirements by virtue of Section 46a-68j-21(11) of the Contract Compliance Regulations.

The awarding agency will consider the following factors when reviewing the bidder's qualifications under the contract compliance requirements:

- (a) the bidder's success in implementing an affirmative action plan;
