- a. Finance Lynne & Angie

  - ii. Ms. Colatrella stated that she talked to Mayor Simmons who agrees with the 1% project but wants to see legislation. David Kooris has offered to help draft legislation for 1%.
  - iii. Mr. Varamo mentioned that Youth Music Grant was going away, and that they money would be put in the Arts and Culture Grant. All applicants who applied for the Youth Music Grant will qualify/apply for the Arts and Culture Grant (\$200,000).

- d. Diversity Val & Dennis
  - Ms. Cooper stated that she is hoping to get on Carmen Hughes (new DEI Officer) calendar to learn more about what her goals are, and to see if they can coordinate together on the arts. Reach out to minority grant recipients
