<u>Summer Street, 777 Summer Street, 0 North Street & 612 Bedford Street – General Development Plan, Final Site & Architectural Plans and Requested Uses and Special Exception Approvals:</u>

Current approval

Requesting approval of General Development Plan, Final Site & Architectural Plans and/or Requested Uses and Special Exception approval to construct a seven story 263,149 sf building comprised of approximately 4,000 sf of ground floor retail/flex amenity space fronting Summer Street and North Street and 376 apartments in a mix of studios, 1-Bedrooms and 2-Bedrooms. A total of 376 parking spaces will be located in a two-story garage beneath the building and 18 parking spaces will be located in an existing surface lot along North Street.

Modifications being requested to allow increase in floor area and reduction in number of residential units and parking spaces.

Mr. Raymond Mazzeo with Redniss & Mead representing the applicant introduced his team and along with his team gave a detailed presentation and answered questions from the Board.
