- Discussion on the Washington Blvd & Tresser Blvd bus shelter regarding an easement. Frank Petise has not received any communication regarding the easement.
- Discussion on the bus shelter located at Tresser Blvd in front of the Marriott Hotel regarding an easement. Frank Petise moved the bus shelter over in order to get the sidewalk fixed.
- Discussion on the 1044 Hope Street (Springdale Shopping center) missing a panel. Still waiting on a panel.
- Discussion on 154 Broad Street & Greyrock Place (#10) bus shelter (across from Macy's). Once the construction in that area gets completed, the bus shelter gets put back.
