  - c. 9 C1-80-1 -Consider preventing elected officers from holding dual offices, including state offices such as state representative or as appropriate with appointed Boards or Commissions 16 Allow the President of the Board of Representatives to issue oath of office
  - d. 18 C3-10-4 Delete "or" before the Town Clerk" In the event the Mayor is or intends to be absent from the City for a period of forty-eight (48) hours or

- more, the Mayor shall give written notice to that effect to the President and/or Clerk of the Board of Representatives and/or the Town Clerk
- e. 19 C3-10-7 Clarify that the Mayor may issue the oath of office (might be a separate Section; make consistent with State law) The committee thought that the Mayor, the Town Clerk, and the President of the Board of Representatives should each be able to issue the oath of office.
- f. 112 C1-40-5 Give Board of Representatives ability to amend charter by a <sup>3</sup>/<sub>4</sub> supermajority vote, which could then be voted on by public referendum
- g. 96 C1-70-3 Board of Representatives should have term limits of 3-4 terms
- h. 97 C1-70-3; C1-70-4; C1-80-1 C1Halve the number of members on the Board of Representatives, either by having one per district or reducing the number of districts to 10
- i. 98 C1-70-3 Give the members of the Representative staggered terms, so
   ½ of the Board is elected every 2 years
- 6. Remaining invitations to be issued:
  - a. Board of Education proper protocol?
  - b. City and Town Clerk L. Ruijter
  - c. Other?
- 7. Continuing our workload:
  - a) 115 Consider how other cities are governed, e.g. Austin
