### C. Agency Plan overview

Ms. Coard reported that the purpose of the meeting was to review and approve the 2021 Agency Plan. Ms. Coard highlighted the Goals and Objectives by each section: Asset Management, Development & Redevelopment, Leased Housing Programs, Supportive & Resident Services, Organizational Administration, Entrepreneurial Activities, and Transformational Activities. The goals are in alignment with COC's Core Objectives for all operating divisions: Corporate Service Group, Operations Service Group, Rippowam Corporation, and Dovetail: SIP. Ms. Coard discussed the Rental Assistant Demonstration (RAD) initiative, which details the conversion of Low Income Public Housing subsidized properties into project based rental assistance subsidies. Ms. Coard provided a breakdown of the capital funding Annual Statement and the five-year capital plan along with work to be completed at specific properties. Mr. Coard noted that residents had an opportunity to participate and provide feedback virtually, via email and by phone due, to the COVID-19 pandemic, but no feedback was provided or submitted regarding the plan.

### **RESOLUTION**

Subject Approve FYE June 30, 2022 Budgets for State Moderate Rent (Lawnhill

Terrace, & Oak Park) and Wormser Congregate Program

**Background:** 

Pursuant to the requirements of the State of Connecticut regarding the operation of the State assisted housing programs; Charter Oak Communities (COC) is required to propose annual budgets to the Connecticut Department of Housing (DOH) and the Connecticut Housing Finance Authority (CHFA). These agencies must approve proposed budgets prior to their implementation.

The State Moderate Rent Program consists of Oak Park (MR-6) and Lawnhill Terrace (MR-68). COC is proposing no rent increase for the upcoming fiscal year.

The Wormser Congregate Program (C-10) includes both Congregate and Operating budgets. COC proposes a total increase of \$50.00 per unit/month for Operating (rent) and no increase to Congregate (service fees). The proposed increase will cover routine management and maintenance costs along with congregate services while ensuring program solvency. (See attached budgets).

Resolution: Be it resolved by the Commissioners of the Housing Authority of the City of

Stamford d/b/a Charter Oak Communities that the Budgets for the State Moderate Rent Program (Lawnhill Terrace & Oak Park) and Wormser Congregate facility are adopted for the Fiscal Year starting July 1, 2021 through June 30, 2022 subject to final approval by the DOH and CHFA as

applicable.

### **RESOLUTION**

**Subject:** Adopt Updated Flat Rent Schedule for all Federal Low Rent Public Housing

Properties.

**Background:** Per 24 CFR 960.253, Charter Oak Communities (COC) is required to establish a flat rent schedule at no less than 80% of the applicable Fair Market Rent (FMR) or based on an analysis of the market rent. Once the flat rent schedule is determined, COC must allow each family the opportunity to select between two methods of determining their monthly amount of tenant rent. The family may choose to pay either a flat rent or an income-based rent. This option is offered to families during the annual recertification

process.

Effective October 1st, 2020, the Department of Housing and Urban Development (HUD) established new FMRs. As a result, COC must establish an updated flat rent schedule. Since HUD has decreased the FMRs, COC must decrease the flat rents accordingly.
