

 - Chairman's Report: a. Congratulations to Chief Louis DeRubeus in being named the City of Stamford's new Director of Public Safety. b. Harbor Fest Funding Request; SoundWaters is has requested the SHMC's annual contribution be raised by \$1000, to \$5000. With guest Bob Mazzone from SoundWaters. c. Shellfish Permit and Water Quality testing; Bureau of Aquaculture (BoA) informed us that 2 of the minimum 5 samplings have been done to this point which has set back the opening. SoundWaters with whom we contracted the task of testing responded that both weather events and difficulty with the days the lab will accept samples as getting in the way. The BoA suggested that the City of Stamford's Department of Health had reached out and offered to help. Also a resident notified the BoA that they had purchased a shellfish permit which is not permissible with the beds being classified as relay

- d. Stamford Ferry Exploratory Meeting: On Thursday 8/25 a meeting was held with various land use officials and stake holders regarding the installation of a ferry terminal at the Villages on Canal St. The ferry would be a low/no emissions 75 passenger vessel that would provide a mix of transportation and recreational uses. The majority of funding would be through a federal grant program.
