Master Plan Work Session -

- BFJ totally revising the existing text and FedEx it to the City by Tuesday, April 8th,
- The Steering Committee will meet on Thursday, April 10th at 2:30 p.m. to review and sign-off that the Draft Master Plan chapters were revised to a stage that they could be posted on the Website.
- If the Steering Committee agreed that the Draft was acceptable to post as a Draft, then the consultant's preferred date of April 22nd for the Public Workshop would be posted and publicity would be sent out,
- The Steering Committee also has the option to move the Public Workshop to alternate dates, such as Wednesday, April 23rd, Tuesday, April 29th, Wednesday, April 30th, or even Thursday, May 1st.

Mr. Woods announced that due to conflicting schedules with Ernie Orgera, Director of Operations, the April 8th meeting would start at 6:45 p.m. instead of 7:00 p.m.
