Subdivision:

<u>Subdivision Application # 4002 Estate of Lillian Lotstein</u> for subdivision of property into two (2) parcels. The property is located on the northeast corner of the intersection of Webbs Hill Road and Dogwood Lane, having an address of 6 Dogwood Lane.

Mr. Dumais provided the Board with a summary of the Subdivision application. After a brief discussion, Mr. Tepper moved to approve the application, Mr. Naumowicz seconded the motion and it passed unanimously with the eligible members present voting, 4-0 (Dell, Williams, Tepper and Naumowicz).

Proposed Land Swap Agreement:

Proposed Three Way Land Swap – City of Stamford and Gaglio for a land swap of identically sized portions of parcels between the City (Smith House) and the Gaglios at Spinning Wheel Lane and Haviland Road.
