### **SPECIAL MEETING MINUTES** Friday, January 9, 2015 – 5:00 pm

A Special Meeting of the City of Stamford, Connecticut Urban Redevelopment Commission (URC) was held on Friday, January 9, 2015.

Commission Chairperson Peter Sciarretta called the meeting to order at 5:01 pm. Commissioners in attendance included Vice Chairperson Rios and Secretary Treasurer Molgano and Commissioner Patterson.

URC Staff in attendance included Rachel Goldberg, General Counsel and Dr. Tommie Jackson, Executive Director.

Other Attendee was Michel Bayonne, URC Special Counsel.

Chairperson Sciarretta called to take agenda items out of order, and received a motion from Vice Chair Rios to take items out of order. Commissioner Molgano made a second to the motion.

Agenda Items 3 (b) and 5 (b) were noted as items for Executive Session. Commissioner Molgano moved to go into Executive Session with a second from Commissioner Patterson. The motion was unanimously approved. General Counsel Goldberg left and the Commission entered Executive Session at 5:10 pm. At 5:54, a motion was made by Vice Chair Rios, seconded by Commissioner Molgano, to come out of Executive Session. It was approved unanimously.

The Commission received information from General Counsel Goldberg and Dr. Jackson regarding Parcel 36. The Commission with a motion by Commissioner Patterson and second from Vice Chair Rios voted to

unanimously approve the appraiser. The motion included authorizing General Counsel Goldberg to proceed with preparation of an engagement letter for signature and delivery to the appraiser.

There was no further business discussed. A motion to adjourn was made by Commissioner Molgano, second by Commissioner Patterson and approved unanimously at 6:23 pm.


