1. Roll Call

At 6:06pm, Commissioner Rios made a motion to go into Executive Session. The motion was seconded by Commissioner Jean-Pierre and carried by unanimous vote. At 6:36pm, Commissioner Meek joined the meeting via teleconference and took over as Chairman. Executive Director Jackson participated in the discussion. No motions were made and no votes were taken. At 6:56pm, Executive Director Jackson left the meeting.

At 6:58pm, Commissioner Molgano made a motion to return to Open Session. The motion was seconded by Commissioner Rios and carried by unanimous vote. Staff members returned to the meeting.


