CALL TO ORDER:

Mr. Newman called the meeting to order at 6:33 p.m. and introduced the Commission Members and staff present.

Mr. Newman introduced the first item on the agenda.

➤ Public Participation Session: Each individual requesting to speak shall send a Chat Message to the Chair stating their name and address for the record. Public participation comments shall be limited to 3 minutes.

Mr. Newman explained the guidelines for the public session since this item has not been on the agenda for some time.

Mr. Newman stated there is one request to speak from Maureen Boylan.

Ms. Boylan spoke about the soccer fields at West Beach.

Mr. Newman stopped Ms. Boylan after the allotted 3 minutes and thanked her for her comments.

Ms. Katz asked to make a motion to allow Ms. Boylan additional time to speak.

NEW BUSINESS:

➤ Springdale Elementary School - Angelo Fusaro, PTO President: Installation of a Gaga field to be built in the playground area.²

Mr. Fusaro made a presentation and answered questions from the Commission.

After a brief discussion, Mr. Tedder made a motion to approve the installation of a Gaga field at Drotar Park.

➤ Stamford Little League - Michael Noto: Mr. Noto will provide details on the merger of Little League baseball in Stamford which will operate under the umbrella of Stamford Little League.³

Mr. Noto made a presentation explaining the merger of all the little league organizations under the single umbrella of "Stamford Little League" and provided details of how the new merged league will be managed going forward.

➤ Stamford Babe Ruth Baseball - James Serafino: Mr. Serafino will provide details on the 50/70 baseball program being run through Babe Ruth's Cal Ripken Charter.⁴

Mr. Serafino made a presentation providing background on the Babe Ruth organization and details on the 50/70 program and made a request for permanent sanctioning in the City of Stamford.

After some discussion, Ms. Hollas made a motion to sanction Stamford Babe Ruth Baseball to manage Youth Travel, the 50/70 program and the Babe Ruth program in the City of Stamford.

➤ Resolution - Authorization of a Pilot Program - Sound Reproduction Devices during Special Events within City of Stamford Parks: The intent is for the Commission to consider adopting a pilot program for 2023 to consider music in the parks as part of Special Events. Conditions of the pilot program would limit music to no more than two (2) hours for any event.⁵

Mr. Newman read the Resolution into the record and provided brief comments citing the Board of Representatives ordinance which relate to the proposed pilot program for Special Events.

Mr. Newman also mentioned a letter received from Board of Representatives members Melinda Baxter and Bonnie Kim Campbell supporting the pilot program and read the letter into the record.

Director Quiñones made a presentation and answered questions from the Commission.

After considerable discussion, it was decided to *Table* this item to the December 21, 2022 meeting.

The ordinace is somewhat vague and could be left up to interpretation. Director Quiñones suggested the Commission work on an ordinance specifically relating to political signage in the parks.

Mr. Murray stated that contrary to what has been thought, when signs are removed due to a traffic hazard or being in the way of park maintenance, they are not thrown out. They are kept and stored at the Parks vault facility.
