<p>Old Business: Infectious Disease Update</p>	<ul style="list-style-type: none"> • Flu - 546 known active cases, 940 cumulative cases that have been reported via hospital laboratory tests. Half of these cases are youth under the age of eighteen (18). Flu vaccines available at Department of Health Clinic at 137 Henry Street by appointment. • RSV – Cases have plateaued. Mostly children from three to nine. 7 day average, presently 1 case per 100,000. 9 active cases 118 cumulatively. 	
<p>COVID-19 Vaccination Update</p>	<ul style="list-style-type: none"> • COVID Cases are being followed. Cases have been steadily increasing throughout Stamford. Thirty (30) cases / daily per every one hundred thousand (100,000). • As of the end of December 2022, Stamford will be losing State sponsored COVID clinics such as the Griffin and Community Health Centers. Health Department Clinic at 137 Henry Street is to continue providing COVID-19 vaccinations. Transitioning to private sector such as pharmacies, and hospitals. 	
<p>New Business: City Email Use</p>	<ul style="list-style-type: none"> • City attorneys reminded Health Commission to use City email, not personal, for correspondence in the event of a FOIA request, or some other legal matter. 	
<p>Affordable Housing</p>	<ul style="list-style-type: none"> • Insufficient affordable housing units throughout the City that has reached crisis level. However, Simmons administration is working on a housing affordability plan to combat this problem via rezoning certain commercial areas into residential zones.
