

## City of Stamford FY2023-2024 Budget Fact Sheet

<u>Simmons Administration Vision Statement:</u> To build a more inclusive, equitable, vibrant, and innovative City where everyone can thrive.

## **Budget Overview:**

- Capital Budget
  - Proposes \$91M in capital project requests and prioritizes investments in school infrastructure, roads and sidewalks, and pedestrian safety projects.
  - Approximately \$56.2M will be funded by General Obligation Bonds and roughly \$35.2M will be from other revenue sources.
  - By staying below the 10% safe debt limit, this proposed budget avoids major increases to debt service costs.
- Operating Budget
  - Total combined City and Board of Education expense budget and reserve for contingency is \$654.7M, a 3.7% increase from last year; City budget supports essential services for residents, with a focus on public safety, health, and welfare, and infrastructure.
  - Proposed total City government expense budget is \$329.2M, representing a 2.98% increase on the city-side, which includes operating expenses of \$191.8M, employee benefits of \$83M, and debt service obligations of \$53.8M.
  - Total Board of Education budget is \$314.8M, with an additional \$4.6M related to City support for education; this combined request represents an increase of 4.3% from the Board of Education.

## Key Priorities & Investments

- Delivering a Fiscally Responsible Budget that Aims to Ease the Property Tax Burden on Residents
  - Recommending holding the personal property and motor vehicle mill rates flat and a two-year phase in of the property revaluation.
  - Limited discretionary City operating budget increases to mission critical positions.

- Minimized major debt service cost increases and found cost savings in retirement benefits.
- Continued expanded senior citizen property tax credit levels.
- Capital Projects
  - Schools Increased bonding authorization for school facility projects by about \$28M and proposes to keep \$20M in reserve for schools; funding authorized for Stamford High, Julia Stark Elementary, Springdale Elementary, Davenport Ridge Elementary, Northeast Elementary, Newfield Elementary, and Rippowam Middle School.
  - Parks and Sustainability funding authorized for Cummings Park, Scalzi Park, West Beach, Barrett Park, Hatch Field Park, Carwin Park, Cove Island, Kosciuszko Park, Northrop Park, and Fort Stamford Park. Additional projects include city-wide tree replanting, tree pit remediation, and a city-wide tree inventory.
  - Roads, Sidewalks, and Pedestrian Safety funding authorized for road and sidewalk paving and pedestrian safety projects.
  - Public Safety funding authorized for public safety equipment to support the Stamford Police and Fire Departments.
  - Housing Adding a staff position focused on housing and investing \$1,250,000 to support the Oak Park 100% affordable housing redevelopment project.
