

#### CITY OF STAMFORD POLICEMEN'S PENSION TRUST FUND BOARD

A Regular Meeting of the Stamford Police Pension Board of Trustees was held on Tuesday, December 13, 2022 at 5:30 p.m.

Present at the meeting were Capt. Michael Noto, Officer Michael Stempien, Commissioner Erik Findeisen, Commissioner Michael Fedele and Mr. Michael Berkoff. Also present were Thomas Deegan of CIC, LLC, Attorney Anthony Macleod and Donna DeVito, Recording Secretary.

The meeting was called to order at 5:35 p.m. by Capt. Noto.

# **Approval - Meeting Minutes from November 8, 2022**

# Reimbursement from HR on one pension recipient COBRA payments

Capt. Noto reported that the City was notified to review the over payment of COBRA payments by the widow of a deceased officer and they are still working on it.

Capt. Noto reported that he had notified an officer of Board's vote on his application of a pension reconsideration and sent the officer forms for his contributions to be returned. The Board reviewed and approved a draft decision to be sent to the officer.

# **Delta Capital Distribution**

A notice was received from Delta Capital Partners that a distribution will be made in the amount of \$321,940 on November 8, 2022. Funds will be wired to the Oppenheimer account.

#### **Golub 9 Distribution**

On November 8, 2022, notice was received from Golub Capital stating that during the third quarter, the Pension Trust Fund's interest in Golub Capital Partners International Rollover Fund 2, L.P. generated a return of 1.6% of weighted average contributed capital (not annualized) and on November 8, 2022, a distribution was made to the Fund in the amount of \$67,636.

On November 8, 2022, notice was received from Golub Capital stating that during the third quarter, the Pension Trust Fund's interest in Golub Capital Partners International 9, L.P generated a return of 1.6% of weighted average contributed capital (not annualized) and on November 8, 2022, a distribution was made to the Fund in the amount of \$13,463.

### **Status of SPPF Audited Financials 2022**

Lt. Noto reported that the audited financials 2022 were almost complete.

# **CIC**

### **Fund Review**

Tom Deegan distributed the monthly financial statements for November 2022. He reported that as of November 30, 2022, the Fund's assets were \$232,466,978. The monthly

performance was 2.62%, quarter performance to date was 3.32%, 2022 year-to-date performance was -4.71% and fiscal year to date performance was 3.80%. He advised that both equity and bond markets rallied sharply in November as softer-than-expected inflation data was a pivotal catalyst. The DJIA was up 5.86%, the S&P 500 was up 5.57% and the Nasdaq was up 6.27%. Mr. Deegan concluded by stating that, all in all, the Fund was in pretty decent shape for the year and he did not recommend making any measurable changes to investments at this time.
