Custodians' Retirement Fund Quarterly Meeting was held remotely via a Zoom Meeting on May 18, 2023.

Alfred Cava, Director of Human Resources called the meeting to order at 11:16 a.m.

- **A.** A motion to approve the Minutes from the April 20, 2023 Meeting was made by Todd Williams and seconded by Jimmy Connors. The motion was approved by unanimous consent.

i. <u>COLA Provisions</u>

Director Cava had no updates to provide the Trustees, but would inform the Board as more information becomes available.

ii. Pension Statement Distribution

Director Cava provided the Board with a list of dates to consider for the presentation on the online pension system through Milliman.

D. New Business:

i. Principal Custody Solutions – Joe DePalma, Jr.

a. Monthly Report

Mr. DePalma reviewed the Administrative Report for the period ending April 30, 2023, which included financials for the Fund, such as opening balance, contributions, distributions, fees and expenses. According to the report, the Fund had a gain for the month and overall gain for the fiscal year to date. Lastly, Mr. DePalma reported that the Fund continues to maintain a healthy cash balance to cover June, July and August.

b. Review Retro Pay Pension Contributions

Mr. DePalma answered a question presented previously by Union President, Eugene Molgano and informed those in attendance that the Retro Pension Contribution was deposited on April 18, 2023, which was confirmed by Controller, David Yanik.

ii. Fiducient Advisors

a. Quarterly Investment Review

Frist Mark Wetzel introduced fellow Fiducient colleagues and consultants, including Timothy Ng, Lucas Hannegan and Matt Fratini. Following the introductions, Mr. Wetzel provided the Trustees with an overview of the Custodians' Retirement Fund Quarterly Investment report for the First Quarter of 2023. Topics of note included a review of the Fiduciary Calendar, Estimated Fee Analysis, Capital Markets Overview and lastly a Portfolio and Manager Review as of April 30, 2023. Overall, Mr. Wetzel reported that the Fund was in good standing relative to peers and that all managers are maintaining their status, while the Fund has about three months of cash for pension payments.
