**APPLICATION 223-12** – Notice is hereby given that the Zoning Board of the City of Stamford, CT will conduct a Public Hearing on **Monday, June 5, 2023** at **6:30pm** through a **web** and **phone** meeting to consider the application of Landmark Square 1-6 LLC and the Cappelli Organization (collectively the Applicant) for Site & Architectural Plans and/or Requested Uses and Special Permit for the redevelopment of Landmark Square Building 3 including demolition of the existing 134,000 sf office building and replacement with 400 apartments, 420 parking spaces, residential amenities and ground floor restaurant/retail space within a new, 31-story building. The subject property is further described as follows.
