**Application 223-20** – Notice is hereby given that the Zoning Board of the City of Stamford, CT will conduct a Public Hearing on **Monday, July 31, 2023** at **6:30pm** through a **web** and **phone** meeting to consider the application of Stavros Aivalis, 589 Bedford Street, Stamford, CT to rezone 589 Bedford Street from the present R-H zoning district to the proposed MX-D zoning district.

EASTERLY: Eighteen and 30/100 (18.30) feet; and

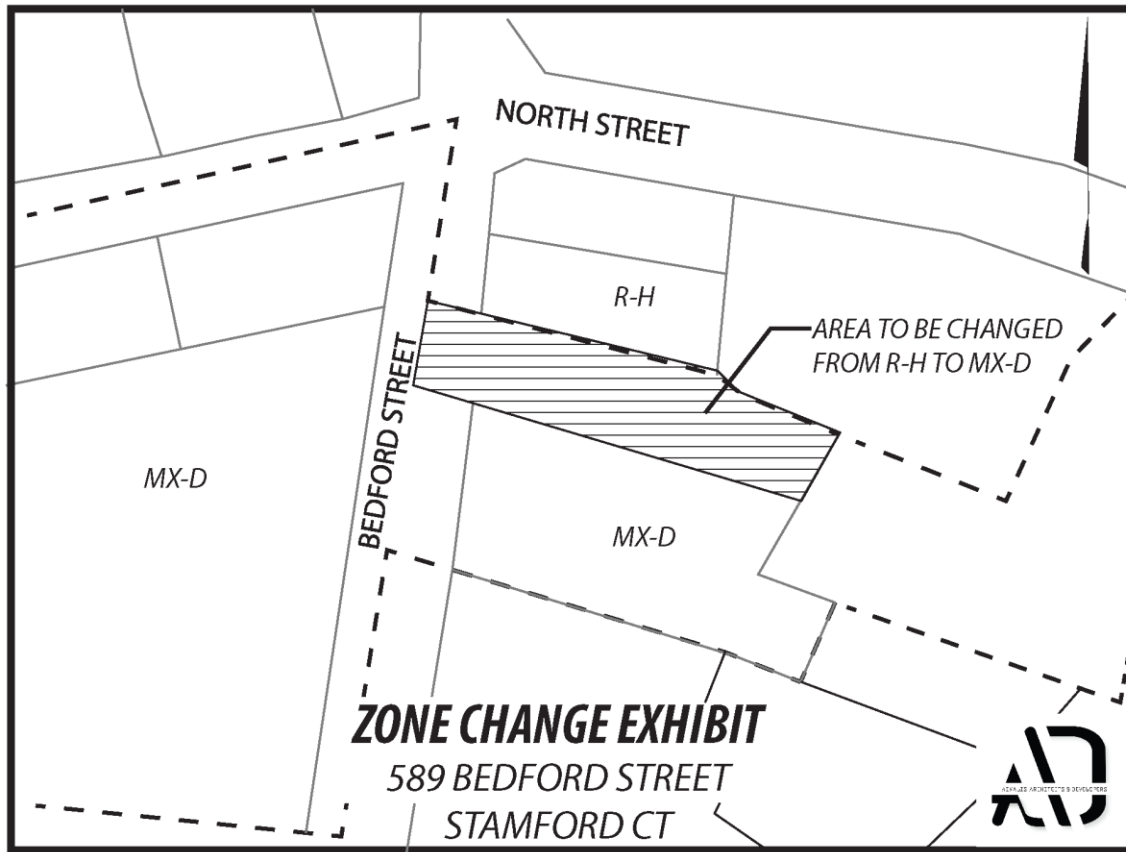
NORTHERLY: Sixty-six and 55/100 (66.55) feet by land of the City of Stamford;

WESTERLY: Fifty (50) feet by Bedford Street.
