

## Stamford Vision Zero Task Force Meeting Minutes

Wednesday July 5<sup>th</sup>, 2023 at 9:30 am via a Zoom Meeting

The meeting was started at 9:32 am

### Old Business

- 1) Transportation, Traffic & Parking Department Updates
  - a. Working on a \$16M USDOT Safe Street and Roads For All grant for Strawberry Hill Avenue.
  - b. Looking at safety based parking tickets such as parking on crosswalks, parking too close to corners, etc. TTP will meet with Parking Enforcement officers to target more safety based violations.
  - c. Repainting downtown crosswalks and possibly widening them as well.
- 2) Police Department/Public Safety Updates
  - a. Traffic enforcement updates
    - i. Traffic Enforcement down 50% since 2019
    - ii. Up 50% in enforcement since last year
    - iii. Up 30% since 2021
    - iv. Increase in pull overs for speeding and stop sign running. Speed related pullovers are now 20% compared to 10% of all tickets.
    - v. Downtown is #1 for tickets
    - vi. Reduced number of stops for broken lights
    - vii. Traffic Enforcement unit has been consistent in issuing tickets before, through, and since COVID
    - viii. 24 new recruits trained in speed enforcement for the patrol division
  - b. Vision Zero Dashboard
    - i. Updates coming to the dashboard including overlaying with census tracts
    - ii. Determine risk factors compared to other towns
- 3) Vision Zero RFP Update
  - a. A consultant has been conditionally awarded for the Vision Zero Action Plan.

### New Business

1. Vision Zero Project Review Form

- a. Moving along and implementing the form for City projects and Zoning Board Projects
2. Washington Blvd and Main Street Pilot Project
  - a. Temporary delineator bump out pilot project
  - b. Working with CTDOT to get approval to implement this project
3. Washington Blvd RSA
  - a. Technical walk through with CTDOT and FHI Studio was held last week
  - b. Various safety enhancements were discussed such as bump outs and raised crosswalks/intersections
  - c. Report being compiled
  - d. Draft report should come out in July/August
4. Speed Cameras
  - a. State Bill legalized speed camera enforcement
  - b. Stamford needs to look at existing City Ordinances and work with TTP, Police, and Public Safety Departments to implement them in Stamford
  - c. There was additional discussion related to speed cameras such as the possible process for implementing them.
5. National Pedestrian Death Update
  - a. More than 7,500 Pedestrians were killed in the US in 2022. The highest amount since 1981.
  - b. Connecticut had 62 pedestrian deaths in 2022
  - c. Connecticut set a record in 2022 for all fatal crashes
