APPLICATION 223-26 – Notice is hereby given that the Zoning Board of the City of Stamford, CT will conduct a Public Hearing on Monday, September 11, 2023 at 6:30pm through a web and phone meeting to consider the applications of 70 Forest Street LLC for Special Permit, GDP, and Final Site & Architectural Plans and/or Requested Uses to facilitate the construction of an attached 2-story parking garage addition. The applications are pursuant to companion Text Change application (223-24) to amend 9.B (P-D Planned Development District) and Zone Change application (223-25) for property at 251 Greyrock Place from the R-H to P-D zone. The subject site is described as follows:

Easterly: 60'± by land n/f of Splendor Condominium (Various Unit Owners); Northerly: 188'± by said land n/f of Splendor Condominium (Various Unit Owners);

Easterly: $74' \pm \text{ by the westerly side of Grove Street}$;

Southerly: 56'± by land n/f of Forest Grove Condominium (Various Unit Owners); and Easterly: 170'± by said land n/f of Forest Grove Condominium (Various Unit Owners).
