Penalty for late filing – Failure to file timely will result in a penalty equal to 25% of the assessment of the personal property. This declaration must be filed or postmarked (as defined in C.G.S. Sec 1-2a) no later than: November 1, 2023

Extension: The Assessor may grant a filing extension *for good cause* (CGS §12-42). If a request for an extension is needed, you need to contact the Assessor in writing by:

Wednesday, November 1, 2023

If you no longer own the motor vehicle assessed in your name last year or moved the vehicle out of this town, you must return this declaration to the Assessor and provide information related to the name of the new owner of the vehicle or to where you moved the vehicle (see below). Otherwise, the Assessor must assume that you still own and have failed to declare your taxable motor vehicle.
