Wherease the Owner plans to seek grants for this Project and divide the work into two separate bidding and construction phases, the first phase being the window and masonry reconstruction and the second being the floor replacement;

Whereas the Architect submitted a Revised Fee Proposal, dated July 26, 2023, in response to the Owner's plans;

Whereas the Owner accepted the Architect's Revised Fee Proposal; and

Whereas the Owner and Architect now agree to the following changes to the Scope of the Agreement, the Initial Information, the Architect's Compensation, and the Project Schedule:

Scope of the Agreement:

§ 13.2.3 - The Scope of the Agreement shall be revised by replacing Exhibit B-1 "The Architect's Revised Fee Proposal, dated August 11, 2020, revised October 6, 2020" with "The Architect's Revised Fee Proposal, dated July 26, 2023."

Initial Information:

§ 1.1.3 shall be deleted in its entirety and replaced with "The Owner's current construction budget, as defined in Section 6.1, is: Phase 1 - One Million Two Hundred Ten Thousand Five Hundred Eighty Nine Dollars (\$1,210,589.00); and Phase 2 - Eight Hundred Forty Eight Thousand Thirty One Dollars (\$848,031.00); which includes the cost of hazardous materials abatement, if required."

The Architect's compensation and schedule shall be adjusted as follows:

Compensation Adjustment:

- § 11.2 Shall be amended by adding the following: "for such services provided prior to the date of this Amendment and thereafter per the Hourly Rate Schedule set forth in Exhibit B-1 The Architect's Revised Fee Proposal, dated July 26, 2023."
- § 11.3 Shall be amended by adding the following: "for such services provided prior to the date of this Amendment and thereafter per the Hourly Rate Schedule set forth in Exhibit B-1 The Architect's Revised Fee Proposal, dated July 26, 2023."
- § 11.7 Shall be amended by adding the following: "for such services provided prior to the date of this Amendment and thereafter per the the Hourly Rate Schedule set forth in Exhibit B-1 The Architect's Revised Fee Proposal, dated July 26, 2023."

Schedule Adjustment:

- § 1.1.4.1 The design phase milestone dates shall be revised from "See documents listed in § 13.2, below" to "See Exhibit B-1 The Architect's Revised Fee Proposal, dated July 26, 2023."
- § 1.1.4.2 The construction commencement date shall be revised to
- "Phase 1 The day after the last day of the 2023/2024 school year; and
- Phase 2 The day afer the last day of the 2024/2025 school year."
- § 1.1.4.3 The substantial completion dates shall be revised to:
- "Phase 1 Before the start of the 2024/2025 school year; and
- Phase 2 Before the start of the 2025/2026 school year."
- § 1.1.4.4 The other milestone dates shall be revised from "See documents listed in § 13.2, below" to "See Exhibit B-1 The Architect's Revised Fee Proposal, dated July 26, 2023."

All terms and conditions of the Agreement not amended by this Amendment shall remain the same.
