#### Commissioner Awards

Chief Shaw began by acknowledging Dispatcher Rich Kulis for his outstanding work at 911 and finding a link that would help see all the schools in the city. Director DeRubeis spoke as well as 911 Supervisor Gaudette.

#### Comments from Public

Amin Hasan spoke to the Commission regarding an incident that happened on June 15, 2017, regarding retired Captain Hohn and Officer Petrone. A Federal Judge gave him permission to come to Stamford just for this meeting. He asked the Commission to review the elongated video version of the incident.

Heather Lindsey spoke to the Commission regarding several issues that have happened over the past 15-20 years. Went thru her entire issue with Dr. Ahudja and his brother who has threatened her. She would like an appointment with the BHU.

John Flynn spoke again about a complaint from 2000. Also stated that Dr. Ahudja's brother threatened him and he has never been prosecuted for his illegal act. Everyone who is being called as a witness against him is being threatened. He also informed everyone their time was up.

## Administrative & Operations Report

He is having officers trained in Laser Speed Enforcement.

Commissioner Fedele asked about the city getting speed cameras. Chief Shaw said Waterbury PD spearheaded speed cameras and we are speaking with them. Director DeRubeis said the city would like to start with certain intersections, make sure the Community is on board and also the cost.
