Beirne Wealth Management Presentation: Fund Update

Before J-O began his presentation, Trustee Fedeli noted that he and Lori had a red-lined version of the Beirne contract and he would look towards next months meeting in July to be ready for a vote.

J-O emphasized that the underlying performance in the broader markets has been negative, despite outperformance by a select grouping of large-cap US equities. This tends to indicate a looming bear market on the horizon. The Fund has predominantly maintained our equity exposure in these large-cap US equities.

The Fund is currently at roughly 10% in cash, which has previously been approved by the Board. This decision was made to protect a portion of the Fund from volatility, while taking advantage of nearly 5% return on cash as is currently being offered.

Beirne is waiting on pricing for a large portion of the Fund, which should be updated in July for a greater detailed conversation as to the state of the Fund.

The Fund remains within its policy guidelines, with the exception of cash as previously mentioned.

NCPERS Conference Recap

Trustees Anderson and Micalizzi attended the first half of the NAF Accredited Fiduciary Track in New Orleans last month. They were hopefully to finish the program sometime late 2023/24.

Discussion on Search for Neutral Trustee

The Trustees are still undertaking measures to locate a Neutral Trustee. Trustee Fedeli noted that there was a candidate that both he and Trustee Anderson met with but he removed his name from candidacy. Fedeli also noted that there was another potential candidate who had surfaced, and he would undertake initial steps to meet with this person.

FOIA Requests for Quarterly Statements

The City passed along information previously about an FOIA request for the Funds quarterly statements by a research analyst from an outside agency named FinNews. Trustee Micalizzi noted that JR Defrancesco from Beirne provided the requested documents. Trustee Fedeli suggested engaging with Corporation Counsel to determine whether or not the request had been satisfactorily completed.

Milliman: Contract for Annual Illustrations

Trustee Micalizzi advised the Board that he had spoken with Yelena Pelletier from Milliman to commence another annual illustration of accrued benefits to current FD employees. Milliman is waiting on year end payroll data from the City to complete this project. The approximate cost to the Fund is \$2,500.00.

A MOTION was made at 1418 by Trustee Gold and seconded by Trustee Anderson to formally engage Milliman to complete this project. MOTION PASSED, all in favor.

Other Business

A search for an administrative assistant to help with clerical work of the Fund is underway.

Trustee Micalizzi spoke with David Yanik to inquire about the annual audit. It is not yet completed as RSM is dedicated to the City Audit primarily. He will keep the Board updated of progress.

Beirne will continue to operate as the Advisor for the Fund under the terms of their former contract, as the new contract is finalized.
