- Oracle – Raquelle is working with Oracle team setting up the department for this new system.
- Second round of interviews for the Manager of Public Health Programs position.
- Social Services Division – Merged with the Health Department and is in the process of relocating to the 8th floor. In addition, Enrolling eligible children into Husky regardless of immigration status. Social Services along with representatives for Police and Liberation Programs will be travelling to Canada to learn more about their managed alcohol programs (MAP) in order to employ something similar in Stamford.
- Mothers and Babies program is restarting again. In addition to classes being offered in English, Maria Millan will be offering the classes in Spanish.
- Family Day – Scheduled for Saturday, September 30, 2023, which is also the flu vaccinations kick-off.
- Nursing: Hired 2 nurses to fill 2 vacancies due to resignations. One nurse has already started working. The other is due to start in October which brings the number of nurses to 37.
- School Nursing – Ensuring children receive their physicals and immunizations to return / attend school.
- Community Nursing – Ongoing. Administration of childhood vaccinations in addition to COVID-19 and flu. Family Day is also flu vaccine kick-off.

<p>Director of Public Safety, Health, and Welfare Mr. Louis DeRubeis</p>	<ul style="list-style-type: none">• Immunizations – COVID-19 vaccines manufactured by Moderna and Pfizer that include the most current variants have been approved by the FDA. These new vaccines will be covered by health insurances for insured individuals and are available free of charge to uninsured / underinsured individuals at pharmacies and will be available (as soon as we can acquire them) at the Health Department Clinic. Grant funding not available for the purchase of these vaccines at this time. Vaccines will be free for uninsured / under insured individuals and those who are insured will be referred by case managers where to go for vaccination. Current vaccines have been discontinued. • Infectious Disease(s) – COVID-19. Slight uptick in cases. 76 active cases. 5.7 rolling average for every 100,000 persons. - COVID-19 Case Management team – Monitors outbreaks in nursing home facilities and schools, especially particular classrooms where outbreaks may have originated from. A meeting between state DPH and state Department of Education scheduled for Friday, September 15, 2023, regarding providing guidance in the area of school outbreaks. • Spoke in remembrance of Reverend Thomas Jackson’s passing due to a traffic accident involving a police officer. Were helpful during the summer wildfires that took place this past June. Grant funding has been received for 3 high tech air monitors. • Food Ratings for Restaurants – FDA food codes don’t give pass/fail for food inspections. Looking to instead provide full food inspections reports online that will be viewable to the general public. Spoke with IT for implementation. • Accreditation – 63% complete at putting together documentation for this process. Brittany submitted for the readiness assessment and information. • Deferred to Mayor’s office. • Stamford Public Schools awarded \$83,000 grant for mental health.
