Draft Minutes –November 14, 2023, Regular Meeting of Fire Commission

Call to order: Commissioner Alswanger called the meeting to order at 5:10pm

Roll Call: Present: Commissioner Alswanger, Commissioner Baker, Commissioner Linares, Commissioner Munger, Interim Fire Chief Morris. Also attending: A/Fire Chief Robles, Barbara Murphy, Fire Administrative Supervisor; Absent: Commissioner Hubbard

Pledge of Allegiance & Moment of Silence: All stood for the Pledge of Allegiance and a Moment of Silence

Public Comment: N/a

Chiefs Report: Chief Morris gave a brief report on the department activities stating that in the past two (2) months the department responded to approximately 2062 calls.

Personnel Items: The CBA and the potential changes to personnel, related to the proposed changes, were discussed briefly. Chief Morris stated that the Department is looking to hire in July/August 2024.

Motion: Commissioner Alswanger made motion to go into Execution Session to discuss Personnel issues at 5:27pm.
