## CALL TO ORDER:

Ms. Hollas called the meeting to order at 6:33 p.m. and introduced the Commission Members and staff present.

Ms. Hollas introduced the first item on the agenda.

➤ <u>PUBLIC PARTICIPATION SESSION</u>: Each individual requesting to speak shall send a Chat Message to the Chair stating their name and address for the record. Public participation comments shall be limited to 3 minutes.

There was no one in attendance who wished to speak.

➤ Review of the November 15, 2023 Regular Meeting Draft Minutes.

### **NEW BUSINESS:**

➤ Capital Budget FY 2024-2025 & Capital Plan FY 2025-2031: The Planning Board will review all Capital Budget submissions at their December 12 and December 19, 2023 meetings with the final version being posted on the Planning Board website by Friday, December 22, 2023. The Public Hearing for the Capital Budget is scheduled for January 16, 2024 at 7:00 p.m.²

Ms. Hollas provided an update on the Recreation Capital Budget submissions and the Planning Board's Capital Budget meeting dates.

**NOTE:** On Thursday, December 14, 2023 the Planning Board made an adjustment to their 2024 Meeting Schedule and changed the date of the Capital Budget Public Hearing to January 23, 2024.

➤ Board of Representatives, Parks & Recreation Committee Meeting - November 30, 2023 - Melanie Hollas, Chair and Michael Tedder, Vice-Chair: Ms. Hollas and Mr. Tedder will provide details from the meeting they attended discussing the Bocce Court costs at Scalzi Park and working with Greenwich's Parks & Recreation at Rosa Hartman and Mianus River Parks. Erin McKenna, Senior Planner, Land Use Bureau, will be setting up walk-throughs of both parks with the Board of Representatives, Parks & Recreation Committee members, Greenwich and the Parks & Recreation Commission. All parties are interested in working more closely together on invasive species removal and native plantings.<sup>3</sup>

Ms. Hollas and Mr. Tedder provided details of the meeting and answered questions from the other Commission members.

### **OLD BUSINESS:**

➤ Lindsay Bridenbaker, Daughters of the American Revolution - Fort Stamford Park. (*Tabled from the November 15, 2023 Meeting*) Follow up to a proposal for a commemorative plaque to be placed in Fort Stamford Park in recognition of the 250th anniversary (2026) of the Revolutionary War and founding of the United States. Date for a site visit as discussed at the November meeting yet to be determined.<sup>4</sup>

Ms. Hollas stated she spoke with Ms. Bridenbaker and set up a meeting at Fort Stamford Park for Friday, January 5, 2024 at 3:00 p.m. to discuss placement of the proposed plaque.

➤ Scofieldtown Park Dog Park: Follow up to the Public Hearing held on October 18, 2023. Erin McKenna, Senior Planner, Land Use Bureau and Aris Stalis, Aris Land Studio, will return to present updates to the project at a second Public Hearing to be scheduled for January 17, 2024.<sup>5</sup>

The Commission had a discussion in follow up to the Public Hearing held on October 18, 2023. The Commission agreed to hold a second Public Hearing on January 17, 2024 as the location of the dog park was moved since the October meeting.

Field Policy Manual Update - Kevin Murray, Director of Parks & Recreation. (Tabled from the **November 15, 2023 Meeting)** Final review and approval of revisions discussed at the November 15, 2023 meeting.<sup>6</sup>

Ms. Hollas stated that on Pages 15, 16 and 18 the following language was added:

Any inactive approved sanctioned groups for adult leagues will be removed from the sanctioned list after two years of being inactive and any youth sanctioned league that is inactive for five years will be removed and must reapply for sanction status.

Ms. Hollas explained that after approving the language, the next step would be to go through the list and update it as per the language above.

Mr. Newman made a motion to approve the language added regarding the terms for the Sanctioned Leagues as discussed.

Seconded by Mr. Tedder

> Field Policy Use - Melanie Hollas, Chair. Ms. Hollas will make a presentation showing updated charts with the number of teams, playing fields, etc. compiled from meetings with Kevin Murray, Director of Parks & Recreation and Meagan Gearhart, Assistant Superintendent of Recreation.<sup>7</sup>

Ms. Hollas and Gabby Silver provided an update on the different teams using the City's fields.

There was discussion on sending a survey from the Commission through the Parks & Recreation Department to try and complete missing information. Questions were added and the proposed survey will be sent to all Commissioners for review.

≥ 2024 Parks & Recreation Commission Meeting Schedule. (*Tabled from the November 15, 2023* Meeting)<sup>8</sup>

Ms. Hollas stated that the Commission does not want anyone to feel disenfranchised and recommended that the December 11 meeting should not be changed and remain as December 18; change the October 16 meeting to October 9 and not change the June 12 meeting due to the possibility of Special Events applications so there is not a long time between meetings.

- Jackie Robinson Park Annual Christmas Tree lighting was held on Tuesday, November 21, 2023.
- Heights and Lights event was postponed the last two (2) Sundays and will not be rescheduled this year.
- Confirming Summer Camp site with Board of Education facilities for the 2024 camp season.
- Attended Parks & Recreation Committee meeting on November 30, 2023 and discussed Bocci Court upgrades and arrangements of shared park space with Greenwich. We will be having a site meeting to be scheduled on plans.
- Park Maintenance worker interviews scheduled for Friday, December 22, 2023. We have six (6) candidates for two (2) positions.
- Barret Park Project Update: City staff to demolish current playground after the new year. Creative Landscape Design to start late January (weather dependent).

- ➤ 2022/2023 Updates Paul Newman, Commissioner: Parks not zoned as parks. 14

Ms. Hollas asked the Commission for any additional comments or questions. <sup>15</sup> (<u>Note</u>: The following is a summary and the complete conversation can be viewed at the Time Stamp shown below.)

Ms. Katz again stated her displeasure with the Commission for their lack of flexibility on the changes with the 2024 schedule and stated she felt that it exhibits a rigid adherence to a non-existent policy about scheduling and is insulting and needlessly exclusionary and is offensive to her and others who observe these Jewish holidays, which is a different type of observance than the other holidays sited, not more important but a different type of observance where electricity, driving and work are not allowed so those who observe are not able to attend the meetings in question. I think the choice of putting convenience of scheduling over the needs of City constituents and a fellow Commissioner speaks volumes.

Ms. Hollas stated she understood her point but it should be said the email which was sent to the Commission was highly insulting and what the inference is of the Commission. I do not believe any Commissioner has any problem with you and your religion the way it was insinuated in the email. We are trying to do our best for everyone in the City. As Mr. Tedder stated I feel it was a good compromise. We are also trying to help the public when they come before us for Special Events application approvals and with too much time between meetings it could be problematic for applicants to get those approvals on time for their event. That would be part of the June 12th meeting date. It is not just being moved up a week but it would be moved up two weeks so that creates a problem between the May and the June meeting and between the June and the July meeting. You can reach out to any of the Commissioners and let us know what you would want to do. You can also vote by proxy for the June 12th meeting. But it was voted on by the Commission.

### **ADJOURNMENT**

Mr. Tedder made a motion to adjourn the meeting; seconded by Ms. Adetola and the vote was carried unanimously.

Ms. Hollas adjourned the meeting at 8:31 p.m.
