

**STAMFORD WATER POLLUTION CONTROL AUTHORITY**

**RESOLUTION AMENDING A RESOLUTION WITH RESPECT  
TO THE ISSUANCE AND SALE OF \$31,070,000 CITY OF  
STAMFORD, CONNECTICUT WATER POLLUTION CONTROL  
SYSTEM AND FACILITY REVENUE BONDS, ISSUE OF 2015**

**WHEREAS**, the Board of Directors of the Stamford Water Pollution Control Authority previously approved resolutions (collectively, the “Financing Resolution”) authorizing the issuance of \$31,070,000 City of Stamford, Connecticut Water Pollution Control System and Facility Revenue Bonds, Issue of 2015, of which \$14,700,000 was issued to finance new money bonds for capital projects set forth on Schedule A attached hereto (the “2015 Bonds”);

**WHEREAS**, the investment of the proceeds of the 2015 Bonds has generated interest earnings in the amount of \$266,506.54, which amount constitutes proceeds of the 2015 Bonds (the “Interest Earnings”);

**WHEREAS**, the City desires to allocate the Interest Earnings to the projects as set forth on Schedule A attached hereto;

**WHEREAS**, the City desires to reallocate the proceeds of the 2015 Bonds to projects as set forth on Schedule A attached hereto;

**BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE WATER POLLUTION  
CONTROL AUTHORITY OF THE CITY OF STAMFORD, CONNECTICUT:**

Section 1. The proceeds of the 2015 Bonds are hereby allocated and reallocated as set forth on Schedule A.

Section 2. All other provisions of the Financing Resolution, except as amended above, shall remain in full force and effect as of the date of the adoption of this resolution.
