Old Business

- 1) Transportation, Traffic & Parking Department Updates
 - a. Construction project updates
 - i. East Main Street Crosswalk Upgrades beginning construction
 - b. Speed cameras
 - i. TTP Spoke with the Board of Representatives Transportation Committee about the topic of speed cameras and automated traffic enforcement.
- 2) Police Department/Public Safety Updates
 - a. Michael Talbot case from Washington Blvd and Main St crash
 - i. Will be sentenced on March 20th
 - ii. This demonstrates the need to have a thoughtful and iron clad investigation process to ensure a favorable criminal proceeding.

 - b. West Main Street Redesign project
 - i. City received RAISE grant from the USDOT for roadway safety upgrades on West Main Street.
 - ii. Look into shorter term projects as well.
 - c. Discussion about wording and language used in Police Press Releases
- 2) Washington Boulevard Road Safey Audit update and next steps
 - a. Washington Blvd Road Safety Audit was recently completed and released by CTDOT
 - b. Currently being translated.
 - c. Looking at developing next steps for safety on Washington Blvd.
 - d. Applied for State Bond funds for a raised intersection on Washington Blvd and Richmond Hill Ave.
 - i. Since the conclusion of this meeting, the State Bond Commission approved this funding.
