NEW BUSINESS:

1. Health and Human Services: Request to create the classification of Director of Housing Services. Bridget Fox, Chief of Staff, presented information about the need for the Director of Housing Services classification. She highlighted that this position will be responsible for coordination of the housing and homelessness program. Jody Bishop- Pullan, Director of Health added that this role will focus on the fair rent, coordination with homeless providers and housing services, tenant landlord rights and many more housing related tasks as described in the job description. This position will be replacing the existing Director of Social Services.

There will be no change in the salary grade. The other social services function will not be eliminated. Those employees will report to other Health and Human Services staff.
