Introduction

The Applicants, 986 Bedford LLC (Owner), Family Centers Inc. (Contract Purchaser) are requesting approval of a Special Permit to allow a Public Charitable Institution use in an existing approximately 15,600 square foot commercial building on a 0.49 acre parcel located at 986 Bedford Street.

Site & Surroundings The property 986 Bedford Street is located at the northwest corner of Bedford Street and Hoyt Street. The building has parking on the ground floor with three floors above. The site also has surface parking along with perimeter landscaping. The area surrounding the property has several commercial uses in its vicinity including a series of retail and service stores located at the northeast corner of Hoyt and Bedford and a branch of Patriot Bank (999 Bedford Street). Corporate offices of Patriot Bank are located to the south of the property across Hoyt Street at 900 Hoyt Street. The area immediately to the north is occupied by townhomes at

1080 Bedford Street. The building 1100 Bedford Street, located north of the townhomes is occupied by a professional office building with medical and dental offices.

Special Permit

The building located at 986 Bedford Street has been used as a Professional Office building. The Family Centers, a non-profit organization founded in Stamford in 1891 is proposing to move to this building from their current offices at 60 Palmer's Hill Road. The proposed used is classified as a Public Charitable Institution per zoning and requires as a Special Permit in the R-MF zoning district. The definition of the Public Chartable Institution is below:

Public Charitable Institutions

Non-profit philanthropic or charitable institutions providing out-patient counseling, consulting, advisory services or related social services to the public, but not including hospitals, medical clinics, nursing homes, or residential dormitories, and not including institutions of a penal or correctional nature or for the care of insane or feebleminded patients or the care of drug or alcohol addiction.

The proposed use is very similar to the Professional Office use already in the building and uses found in the surrounding areas and the same parking requirement is applicable to the proposed use as a Professional Office. No changes are proposed to the building or site. The existing 47 parking spaces will remain as present.

Referral Comments

Planning Board

During their regularly scheduled meeting held on Tuesday, March 26, 2024, the Planning Board recommended approval of the proposed Special Permit request and found that the request is

consistent with Master Plan Category 4 (Residential – Medium Density Multifamily).

Engineering Bureau

The Engineering Bureau by letter dated April 4, 2024, stated that the department does not object to the application moving forward and recommended that the Applicant ensure compliance with

the Stormwater Drainage Manual.

Transportation Traffic and Parking Bureau

In an email dated April 23, 2024, Transportation Traffic and Parking Bureau made a note that they

have reviewed the application and did not have any comments on it.

Environmental Protection Board

In a letter dated March 20, 2024, the EPB staff stated that it has no objections to the proposed

change of use.

Staff Recommendation

Staff recommends approval of the Special Permit use 'Public Charitable Institution' for 986

Bedford Street which will facilitate the expansion and continued operation of a vital Stamford

institution.
