Capital Market update was provided by Joseph J. Matthews. Information was shared with Trustees on Wealth Management Perspectives and Leading Economic Indicators. Mr. Matthews provided an overview of the Executive Summary, which showed that the market rallied to an all-time high and again indicated that the market is calling for a soft landing. Further, there is pressure on small businesses, and regional banks, which is why fundamentals and active management is important.

Kevin Nichols reviewed the Fund Performance, Asset Allocation, Portfolio Growth, and the Manager Performance report as of April 30, 2024. Overall, the current portfolio is in-line with expectations with a portfolio that is focused on generating enough cash for liability payments and building for long-term success. Looking forward to next month, Morgan Stanley will have suggestions for the Fund to raise cash.
